CORRECTION!

An issue that has caused much concern lately is the Auto-Extrication Agreement or “jaws of life” and its use within the municipality. We would first like to clarify an error printed in the last newsletter. The agreement with Laurentian Hills and Deep River does allow for assistance on Head, Clara & Maria municipal roads if required. Our apologies if this incorrect information caused any concern. Please note, that issue was not discussed during Council deliberations on the matter. It has since been clarified that a number of members of Council were aware that coverage existed on our roads during the agreement.

Although Council rescinded its original decision and has now been notified that we will have continued coverage; it should be noted that the roads within our municipality which have the most “logging” traffic are the Brent Road and the Bissett Creek Road. Neither of these roads (or Highway 17) are municipal roads but instead are Provincial Forest Access Roads. Whether HCM continued in the agreement with DR and LH did not matter when it con-

cerns coverage on those roads. They are not HCM responsibility. (MR)

BY-ELECTION CALLED!

At its meeting of Friday, December 2, 2011 Council passed a by-law declaring a seat on Council vacant due to the resignation of Ed Aiston and authorized a municipal By-Election be held to fill the vacancy.

Nomination Day is Friday, December 30, 2011. You have from the date of passage of the by-law until 2:00 p.m. on Friday, December 30, 2011 to file your nomination as a candidate in the **by-election to be held on Monday, February, 13, 2012.**

Should there be only one nomination, that person will be acclaimed and there will be no cause for an election.

If required an advanced poll will be approved via by-law of Council and will be advertised in the NRT, on our website and on the usual bulletin boards. WASTE MANAGEMENT BY-LAW ADOPTED!

Also at that meeting Council adopted a comprehensive by-law regulating garbage and recycling. Beginning April 1, 2012 full enforcement of the new requirements will commence. Up to that time, Council will focus on public education and communication ensuring that everyone knows what will be required of them.

The short version is that beginning in April of 2012, tipping fees will be implemented for each and every disposal site user. Bag limits for residential use have been limited to 1 bag per household per week, whether dumped at the site or collected. (There are exemptions for specific circumstances however; they will need to be discussed with staff.) Any “garbage” to be deposited in the municipal landfill or collected will require an additional charge of \$1 per bag or appropriate tipping fee. NEVER place lighted candles on or near the Christmas tree. When large amounts of needles begin to fall off, it's time to get rid of the tree.”
