SUBJECT: Algonquins of Ontario Land Claim
Preliminary Draft Agreement in Principle
Draft Descriptive Plans for Proposed Settlement Lands

In my December 17, 2012 memorandum to you about the Preliminary Draft Agreement in Principle (PDAIP), I undertook that early in the new year copies of more detailed descriptive plans would be provided for proposed Algonquins of Ontario (AOO) settlement lands located in your municipality.

The purpose of this memo is to provide you with the relevant descriptive plan(s) for your municipality. Like the PDAIP, these draft plans are public documents. If you have any questions about a descriptive plan or require interpretation assistance, please call Heather Robertson, Senior Negotiator, Ministry of Aboriginal Affairs at 1-705-564-6870.

As noted in our discussions with municipalities, no land transfers will occur until after a Final Agreement is negotiated, ratified and in effect. This will take several years. Once settlement land is transferred, the AOO will become private land owners, subject to the same laws and requirements as other private property owners unless otherwise specified in the Final Agreement.

We are planning a series of public information sessions at various locations. The logistics are complicated and we are trying to satisfy as many people as possible. We will get back to you as soon as possible with definite dates and locations. The meetings will be advertised and we will be sending out advance notice to the Committee of External Advisors and Municipal Advisory Committee as well.

In the meantime, we are meeting with landowners who require access across proposed settlement lands and others with legal interests on those Crown lands that have been identified for potential transfer to the Algonquins of Ontario.

Municipal staff and the public, including ratepayers and those with other interests in your municipality, will have an opportunity to learn more about the Preliminary Draft AIP at the public information sessions.

TO THE IMMEDIATE ATTENTION OF THE CLERK AND COUNCIL

January 30, 2013

Here's what Premier-Designate Kathleen Wynne has said so far about her priorities
(A quick summary of sound bites this week and during the convention)

- Will stay the course on the economic plan to eliminate the deficit by 2017-18 and as part of her leadership campaign committed to restricting overall spending increases to 1% below GDP growth after 2017-18 until Ontario's debt-to-GDP ratio returns to 27% (the pre-recession 2007 level). *(As provincial budget constraint responses continue to be identified, AMO remains firm that it will help government find efficiencies, but the upload Agreement we have with the government must not be delayed).*
- Wants to move forward to implement the Report of the Commission on Social Assistance Review which identified a large number of recommendations and she is asking for an implementation plan. *(Improving how those in need receive services is a shared interest but from AMO's perspective, if service functions such as Ontario Disability Support Program are to be transferred to and integrated with Ontario Works, then the upload Agreement and full mitigation of any impacts on property taxpayers need to be part of any transfer agreement).*
- Solving gridlock in Greater Toronto Area/Hamilton region and other urban areas is about how best to do this in terms of revenue tools; if not; calls on federal government to work on a dedicated national transit fund. *(AMO recognizes the need for transit funding mechanisms to get the most of*

the lifecycle of the current system while at the same time expanding systems to deal with current capacity and growth needs).

- Will continue to build on other infrastructure investments (*AMO has called for a dedicated roads and bridge fund and with the Province a joint framework for going forward was produced in 2012).*

AMO will track any future commentary on priorities during the transition and the days going into the Throne Speech. (The Throne Speech can be expected shortly after the resumption of the Ontario Legislature which is likely to occur on February 19th). Our work on profiling key priorities, some of which include: changes to make arbitrators more accountable and transparent; looking ahead at municipal fiscal sustainability; changes to the *Municipal Election Act* before 2014; advocacy on infrastructure program design; impacts of source water protection; and how we can build more predictability into the land use planning and decision-making process.

In congratulating her, AMO President said that the Association acknowledges her strong belief in the role municipal government plays in making Ontario successful. From our experiences with her as former Minister of Municipal Affairs and Housing, in Transportation and as a Co-Chair of the AMO-Province Memorandum of Understanding (MOU) meetings, we know she wants ideas and will explore options and that this comes about from open and frank discussions. The MOU Table is a valuable pre-consultation tool and joint problem solving forum that we are confident members of her Cabinet will want to use more extensively.

Yesterday, Wynne rounded out her Transition Team. It is led by Monique Smith, former MPP and Cabinet member and includes:

Dear Community Leader

We are writing as parents interested in beginning a local campaign to create awareness of the bullying rampant within our schools, organizations and community. We are simply an informal parent group with no specific skills in dealing with these issues, hence our letter to you.

We are looking to local groups, school boards, parent teacher associations, mental health associations, police, and municipal councils etc. to ask for assistance in moving forward. We are willing to provide leg work to work out logistics but are looking for professionals to assist in providing content for talks, programs and implementation for our schools, clubs and community. We believe that a coordinated effort with the same message will be most effective.

We would appreciate any assistance that you would be able to provide be it direction, contacts, advertising of awareness, willingness to lead or simply advice.

We have created a group on Facebook entitled "Our Community against Bullying" and hope to help our kids realize that bullying is not going to be tolerated in our community. This is simply a venue for sharing stories and information. We realize that there are already extensive programs created and available from a number of sources but without reinforcing the rules, they are ineffective. What we want to do is create awareness.

We need to recognize kids for doing what is right. How do we do that? Rewards? Community recognition? We are open to suggestions but firmly believe that penalizing the bullies just doesn't work. We feel that we need to create a community wide culture of awareness so that the bullies are not tolerated. We hope to be able to modify their behaviour through positive means, not deterrents which just don't seem to be working. Again, we are open to suggestions and are willing to provide the time needed to make them work.

We plan to have an informal meeting of interested parents in the near future to discuss this issue and opportunities for positive steps to affect change. Following that we will contact you to determine if your organization can assist us in any way. Please feel free to contact us with suggestions prior to that.

Together hopefully we can affect some change to make our community safer for our children before another young person, be it the child doing the bullying or the one being bullied, becomes another statistic. Thank you for your consideration of this important issue.

I am sending this to you so that you are aware of this, since this email will likely come to your attention from the Mayor's office. All the follow up will be handled directly by regional coordinators from Autism Ontario. I will not be involved in the day to day logistics. Many of them have Autism, ADHD, FASD, etc. Ultimately you want them to develop into TAXPAYERS, not dependants on society. We have met at FCM and AMO conferences over the past 16 years, first through my role as Director Business Development with the FCM and for the past 10 years through my involvement with Municipal World. During this time I have engaged many of you in discussions about Autism.

Among you there are parents, grandparents, etc. with individuals in your families who have Autism. For those of you who have this connection, you know that the support of the community is so very important. "It takes a village to raise a child." My son, who has Asperger's Syndrome, is in his third year of university. My brother had Autism and lived nearly all his life institutionalized at great expense to government.

At the **AMO Annual Conference** in August, the Autism Ontario flag raising effort was brought forward at the time Kathleen Wynne, as Minister of Municipalities, addressed all of you. I have worked with people like Kathleen and John Tory for years to help increase awareness and services for people with ASD. John is Hon. Chair for Unity for Autism.

The flags have been generously paid for by the Bank of Montreal. My friend Jim Kelsey is a senior executive with the Bank and he is on the Board of the Geneva Centre for Autism, an Ontario Government funded support agency. Jim has an adult son and grandson with Asperger's. BMO's involvement in the "**Raise the Flag**" initiative is a continuation of their years of generosity and support to make life better for ASD individuals and their families in Ontario.

WAAD is now recognized by the Government of Canada through the efforts of Mike Lake MP (Edmonton) whose teenage son has Autism. All elected officials will want to see the following video...an MP making a real difference.

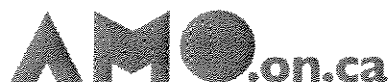

Dear Treasurer:

I am writing to provide information regarding the payments that are issued annually in respect of the former property tax on hydro-electric generating stations (the power dam special payment program).

In September 2012, I wrote to inform you that the power dam special payment program is being examined in the context of a broader review of government programs to ensure they continue to meet their policy objectives while taking into account the province's fiscal situation.

I am following up to advise that for the 2013 and 2014 taxation years, the payments issued to municipalities under the power dam special payment program will be maintained at their 2012 levels. During this period, the ministry will be consulting with its municipal partners about the future design of the program. The focus of the review will be on issues that have arisen over time that were not part of the original program design.

Despite the province's economic and fiscal challenges, municipalities are continuing to benefit from the uploads in accordance with the timetable agreed to through the Provincial-Municipal Fiscal and Service Delivery Review (PMFSDR). In fact, in this year alone, municipalities will see an estimated benefit of almost \$1.4 billion in reduced costs as a result of provincial uploads. These uploads have ensured that more property tax dollars are available to you for important municipal priorities, including investments in infrastructure and economic development.
