Government Introduces Changes to Land Use Planning and Development Charges Legislation

AMO will be reviewing the Bill in detail once it is posted. In the meantime, the following are the highlights of the changes as we understand them.

Streamlining Land Use Planning and Appeals in Ontario

The legislative amendments to the Planning Act are aimed at increased public participation, improved municipal control over decisions, and better dispute resolution.

HIGHLIGHTS:

- The amendments would revise the development approvals system to a "community planning permit system" which would enhance input from residents, municipal staff and developers. This system would coordinate zoning, site plan, and other development applications so a proposed development would be considered and approved as a whole than in pieces.
- Bill would require official plan policies to explain how and when the public is consulted. In addition, municipalities would have to provide an explanation of how public input has influenced planning decisions. Planning Advisory Committees would be required to include citizen representatives.
- Official Plan reviews would be extended to ten years from the current five-year review period. It is anticipated that this would reduce appeals. In addition, there would be no amendments to the Plan in the first two years except those initiated by the municipality. Likewise, once the community planning permit system is established, it would not be subject to private appeals for five years.
- The Province will introduce a process to define "minor" for minor variances.
- Dispute resolution will be promoted through limiting what is appealable and by introducing a 90 day "pause" to allow resolution of official plan issues.

There was considerable, in-depth consultation with AMO's Planning Task Force on the planning process challenges and we look forward to confirming what advice was taken.

Development Charges Act Proposals

Changes to the Development Charges Act are intended to help municipalities cover costs while increasing transparency and support higher density development.

HIGHLIGHTS:

06/03/2015

- Capital costs for transit would be recoverable at 100% and waste diversion capital costs would become an eligible service area but not landfills.
- Adds greater onus for oversight and reporting on funds and charges on development that fall outside of what is allowed in legislation.
- Reporting practices for how development charges are collected and spent, including those charges under Section 37 of the Planning Act (bonus, parkland dedication) will be devised. It is expected that there will be more stringent oversight of development charges funds and how these funds fit into long term planning and asset management.
- A significant proposal is that "development charges would be payable at the time the first building permit was issued for a building".
- A Development Charges Working Group is proposed to be created to provide additional advice on outstanding complex issues.

While some of these changes to the DCA reflect AMO advice given during consultations, a more detailed review will be required to consider the impacts of these proposed changes to municipal operations. The inclusion of transit and waste costs represents a step in the right direction but other services remain either discounted or not included at all which does not allow us to say growth is truly paying for growth.

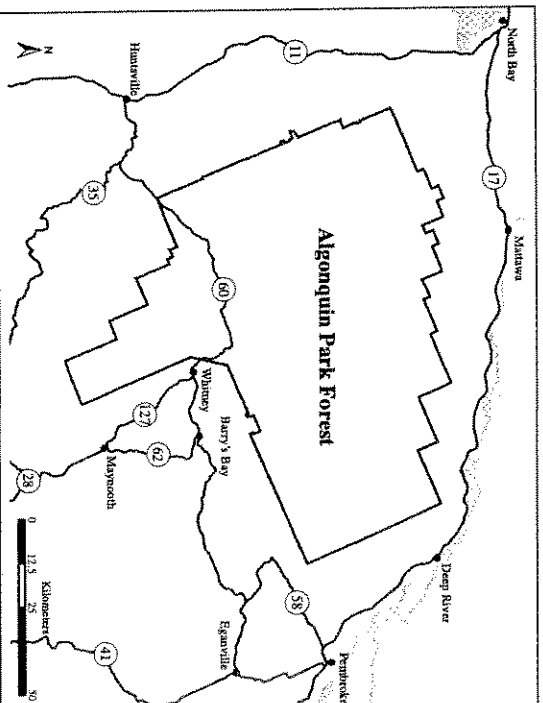

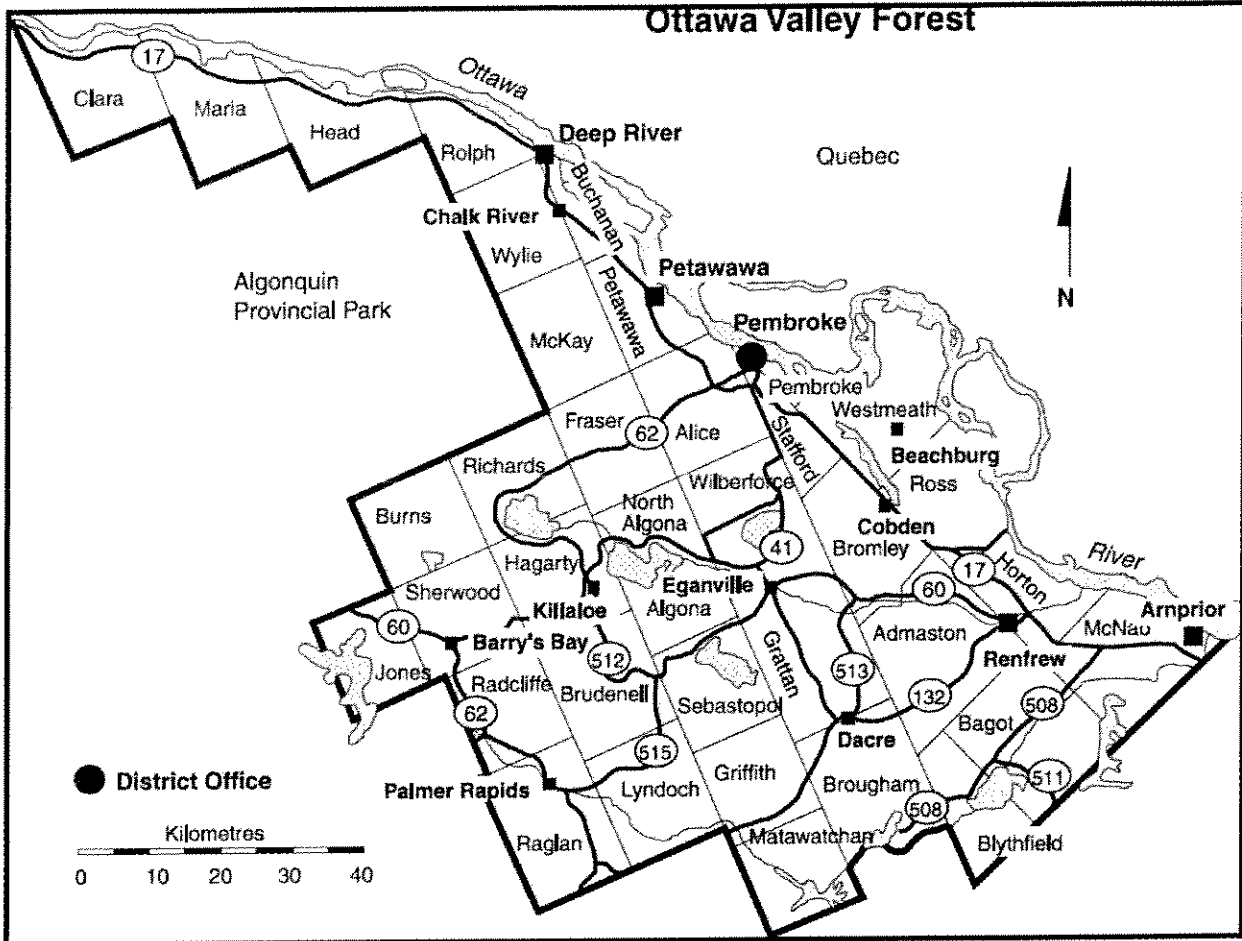

An Act respecting criminal record checks for volunteers

Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Ontario, enacts as follows:

Purpose

1. The purpose of this Act is to promote volunteerism by reducing the frequency with which an organization that retains the services of a volunteer can require a criminal record check for the volunteer and by reducing the cost to a volunteer of obtaining a criminal record check, while still ensuring public safety.

Definitions

2. In this Act,

“criminal record”, with respect to a person, means a record of the offences under the Criminal Code (Canada), the Controlled Drugs and Substances Act (Canada) or any other Act of Canada of which the person has been convicted and for which the person has not received a pardon under the Criminal Records Act (Canada); (“casier judiciaire”)

“criminal record check”, with respect to a person, means a copy of the person’s criminal record, the copy of which complies with the authenticity requirements that are prescribed in the regulations made under this Act; (“vérification du casier judiciaire”)

“organization” includes a person or body; (“organisation”)

“volunteer” means a person who performs work or supplies a service but who receives no monetary compensation for doing so, other than an allowance for expenses or an honorarium. (“bénévole”)

Non-application of Act

3. This Act does not apply in a municipality where a police force does not charge any fee for releasing a criminal record check for a volunteer to the volunteer or to an organization that proposes to retain the services of the volunteer.

Frequency for criminal record checks

4. (1) An organization that retains the services of a volunteer shall not require the volunteer, as a condition of starting to act as a volunteer with the organization, to provide the organization, or to consent to having a police force provide the organization, with a criminal record check for the volunteer if the volunteer has provided the organization with a criminal record check for the volunteer that is,

- (a) dated less than one year before the day on which the volunteer starts to act as a volunteer with the organization; and
- (b) the most recent criminal record check that the volunteer has obtained.

Notice of pending proceedings

(2) An organization that retains the services of a volunteer may require the volunteer, as a condition of starting to act as a volunteer with the organization, to provide the organization with notice of,

- (a) all proceedings that have been commenced against the volunteer and that could result in the volunteer being convicted of an offence where the conviction would be added to the volunteer’s criminal record; and
- (b) the final disposition of the proceedings described in clause (a).

Subsequent criminal record checks

(3) An organization that retains the services of a volunteer shall not require the volunteer, as a condition of continuing to act as a volunteer with the organization, to provide the organization, or to consent to having a police force provide the organization, with a criminal record check for the volunteer dated less than one year after the date of the most recent criminal record check for the volunteer that the organization has received.

Exception

(4) Despite subsections (1) and (3), an organization that retains the services of a volunteer may require the volunteer, as a condition of starting or continuing to act as a volunteer with the organization, to provide the organization, or to consent to having a police force provide the organization, with a criminal record check for the volunteer at any time if,

- (a) the organization has actual notice or reasonable grounds to believe that a conviction for an offence has been added to the volunteer's criminal record since the date of the most recent criminal record check for the volunteer that the organization has received; or
- (b) the circumstances prescribed by the regulations made under this Act exist.

Providing additional criminal record checks to volunteer

5. (1) If a police force releases a criminal record check for a volunteer to an organization in response to a request of the organization and if the request of the organization includes a request of the volunteer for a maximum of five additional originals of the check, the police force shall, at no additional charge when releasing the check to the organization, release the additional originals to the volunteer that the volunteer has requested.

Same, original request by volunteer

(2) If a police force releases a criminal record check for a volunteer to the volunteer in response to a request of the volunteer and if the request includes a request for a maximum of five additional originals of the check, the police force shall, at no additional charge when releasing the check to the volunteer, release the additional originals to the volunteer that the volunteer has requested.

Regulations

6. The Lieutenant Governor in Council may make regulations,
- (a) prescribing anything described as prescribed in this Act;
 - (b) specifying time periods for complying with obligations specified in this Act.

Commencement

7. This Act comes into force on the day it receives Royal Assent.

Short title

8. The short title of this Act is the Helping Volunteers Give Back Act, 2015.

EXPLANATORY NOTE

The Bill enacts a new Act with respect to criminal record checks for volunteers. The Act does not apply in a municipality where a police force does not charge any fee for releasing a criminal record check for a volunteer.

An organization that retains the services of a volunteer is prohibited from requiring a criminal record check for the volunteer, as a condition for the volunteer's starting work with the organization, if the organization receives a criminal record check for the volunteer that is dated within the year before the day on which the volunteer starts work with the organization and that is the most recent criminal record check that the volunteer has obtained. The criminal record check must meet the authenticity requirements specified by the regulations made under the Act. The organization can also require the volunteer to provide notice of all pending criminal proceedings and the final disposition of those proceedings.

After a volunteer starts work with an organization, the organization can require a new criminal record check from the volunteer dated at yearly intervals. In addition, the organization can require a criminal record check for a volunteer at any time if the organization has actual notice or reasonable grounds to believe that a conviction for an offence has been added to the volunteer's criminal record since the date of the most recent criminal record check for the volunteer that the organization has received.

When a police force releases a criminal record check for a volunteer, whether to an organization or to the volunteer, the police force is required to release a maximum of five additional originals of the check to the volunteer at no additional charge if the volunteer so requests.

Dear Reeve Gibson,

I understand the fiscal challenges that municipalities are facing and that your tax dollars have to be used effectively. That's one of the reasons I was so disappointed to learn that some social housing providers are being forced to pay more than they should for services.

As you know, provincial legislation makes it mandatory for affordable housing providers to purchase gas and insurance through the Housing Services Corporation (HSC). A number of municipalities have found that they are paying more for gas than if they were to purchase it through other sources. As well, many providers are paying HSC an opt out fee (2.5% of the premium) in order to be allowed to purchase less expensive insurance that provides equal or better coverage.

I believe that affordable housing providers should be allowed to purchase these items at the best possible price – whether it is directly, jointly with the municipality, through Local Authority Services, or through HSC. I also have concerns about recent spending at the HSC, including frequent international travel and money transferred to subsidiaries and other for-profit companies.

To save municipalities money and ensure affordable housing dollars are used effectively I recently introduced the *Housing Services Corporation Accountability Act*. If passed, this Act will:

- Save affordable housing providers money on natural gas and insurance by removing the mandatory requirement to purchase them through the Housing Service Corporation;
- Restore accountability by requiring HSC to report salaries over \$100,000 as municipalities and government agencies do; and
- Give the Provincial Auditor the authority to audit the HSC without requiring a Minister's request.

I ask for your support for this bill to ensure that affordable housing dollars can provide the maximum benefit to help those who need it most. In case it is helpful I have enclosed a sample resolution of support.

Housing Services Corporation Accountability Act, 2015

EXPLANATORY NOTE

The Bill amends the *Housing Services Act, 2011* in the following ways:

1. Section 150 is amended to permit the Auditor General to audit the accounts of the Housing Services Corporation and of each of its subsidiaries.
2. Section 151 is amended so that members of the Housing Services Corporation such as service managers and local housing corporations are not required to participate in any of the Corporation's programs or activities.

The Bill also amends the *Public Sector Salary Disclosure Act, 1996* to specify that the Housing Services Corporation and each of its subsidiaries are employers for the purposes of the Act.

An Act to amend the Housing Services Act, 2011 and the Public Sector Salary Disclosure Act, 1996

Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Ontario, enacts as follows:

HOUSING SERVICES ACT, 2011

1. (1) Section 150 of the *Housing Services Act, 2011* is amended by adding the following subsections:

Auditor General

(2) The Auditor General appointed under the *Auditor General Act* may audit the accounts of the Corporation and of each of its subsidiaries.

Access to records and information

(3) When the Auditor General conducts an audit under subsection (2), the Corporation and its subsidiaries shall give the Auditor General and employees of the Auditor General access to all records and other information required to conduct the audit.

(2) Section 151 of the Act is repealed and the following substituted:

Member participation not required

151. Members of the Corporation such as service managers and local housing corporations are not required to participate in any of the Corporation's programs or activities described in section 124.

PUBLIC SECTOR SALARY DISCLOSURE ACT, 1996

2. (1) The definition of "employer" in subsection 2 (1) of the *Public Sector Salary Disclosure Act, 1996* is amended by striking out "and" at the end of clause (b), by adding "and" at the end of clause (c) and by adding the following clause:

(d) the Housing Services Corporation and each of its subsidiaries;

(2) Subsection 2 (1) of the Act is amended by adding the following definition:

"Housing Services Corporation" has the same meaning as in the *Housing Services Act, 2011*;

COMMENCEMENT AND SHORT TITLE

Commencement

3. This Act comes into force on the day it receives Royal Assent.

Short title

4. The short title of this Act is the *Housing Services Corporation Accountability Act, 2015*.

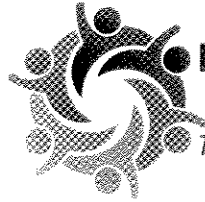
Sample resolution for Municipal Council

WHEREAS social housing providers in Ontario are currently required to purchase natural gas and insurance through the Housing Services Corporation (HSC) or pay a fee to purchase elsewhere; and

WHEREAS social housing providers should have the right to obtain natural gas and insurance at the lowest cost to provide value to those in need of affordable housing and all taxpayers; and

WHEREAS the HSC should be subject the same level of accountability and oversight as government agencies;

Please be advised that the Council of the Corporation of the County of Renfrew supported the following resolution from the Township of Head, Clara and Maria on February 26, 2015:

WHEREAS the province has recently attempted to improve its revenue situation by increasing the costs of Ontario Provincial Police Billing and in 2014 attempted to claw back the Power Dam payments affecting many Ontario municipalities;

AND WHEREAS a review document by the Ministry of Finance of the Provincial Land Tax (PLT) received from property owners in unorganized territories for provincial services has recently been presented for comment and details some significant inequities between how properties are taxed and the benefits received from the province in comparison to other municipalities;

AND WHEREAS it is understood that this paper focuses on the discrepancies between unorganized areas and organized municipalities in Northern Ontario it also affects small rural municipalities in Southern and near Northern Ontario;

AND WHEREAS numerous rural Ontario municipalities have many of the same challenges as those in unorganized territories due to isolation, low population density, and distance to services but do not benefit from exemptions, subsidies and funding received by Northern Ontario residents;

AND WHEREAS these small rural municipalities provide the bare minimum in services to their constituents such as maintenance of roads, garbage collection, scant recreation and a public library not being able to afford luxuries such as local policing, emergency services, utilities, water and sewer, public health, public education, or social services within their own municipality although they are demanded to provide financial support at the county and provincial level;

AND WHEREAS the average PLT paid per household in northern unorganized areas has not changed significantly since the 1950s;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby beseech the Minister of Finance to bring the PLT payment program in Northern Ontario's unorganized areas in line with other Ontario tax payments so that these residents pay their fair share of provincially operated services which they benefit from but do not contribute towards lowering the burden placed on small rural "Southern" Ontario municipalities and northern organized municipalities;

AND FURTHER THAT these increased revenues be used to offset the demands placed on all small rural Ontario municipalities with increased OPP Billing, reduced transfer payments and the proposed Power Dam compensation reductions;

AND FURTHER THAT this resolution be circulated for support.

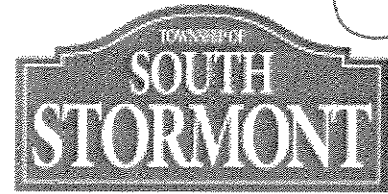

Thank you for copying me on your letter to Premier Kathleen Wynne regarding Council's resolution about the Annual Report of the Environmental Commissioner of Ontario with respect to forest management initiatives in Algonquin Provincial Park. Premier Wynne has also shared your concerns with me.

I appreciate the Council's concerns with the report's recommendation. For generations, we have been able to protect what many see as the Crown jewel of the Ontario provincial parks system while allowing sustainable forest management activities in the park.

As noted in the County of Renfrew's resolution, sustainable forest management activities in Algonquin Provincial Park benefit the economy and the forestry industry. Forest operations support at least 2,800 jobs within the region and contribute about \$110 million to Ontario's economy each year. In addition, the wood supply has primarily supported 13 mills in surrounding communities, such as yours. The available harvest area is approximately 12,000 hectares per year. In recent times, forest operations used less than 8,000 hectares per year. Ontario Parks will continue to balance the protection of Algonquin Provincial Park's natural heritage with sustainable forest management.

My ministry is committed to educating the public on the park's sustainable logging operations. The park has a dedicated logging museum along with a current forest management component at the Visitor Centre. Museum attendance is over 50,000 while the Visitor Centre, which also explains the importance of forestry in the park, draws in an annual average of 160,000 visitors.

You may be pleased to know that the park's sustainable logging practices are highlighted through an extensive set of staff-led interpretive programs accounting for nearly 21 per cent of the entire park's staff-led interpretive programming.

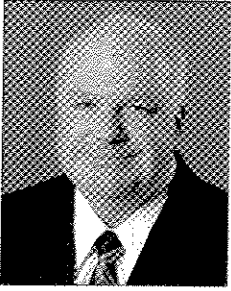

Thank you for your letter concerning the new Ontario Provincial Police billing model. I appreciate your taking the time to bring this matter to my attention.

The Ontario PC Caucus understands and acknowledges the current issues surrounding the cost of policing. We believe the direct result of the provincial government running a \$12-billion annual deficit is that municipalities are paying for provincial mismanagement.

This Liberal government has cut funding to municipalities time and time again, be it through the Ontario Municipal Partnership Fund, canceling the connecting links program, or by ignoring issues with joint and several liabilities. They have increased costs for municipalities on one hand while cutting transfer payments on the other, that's not a solution for municipalities experiencing large increases in policing costs.

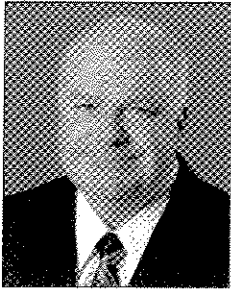

Today, 1.9 million people in Ontario live below the poverty line. They struggle to put food on the table or to pay the rent. Their struggle affects us all – the social and economic cost of poverty in Ontario is estimated at almost \$40 billion a year.



Last year Premier Wynne committed to building “a fairer and healthier Ontario”. The government renewed their commitment with a second Poverty Reduction Strategy and a promise to end homelessness in our province.

Now is the time to invest to move these promises forward – funding needs to be in the 2015 Ontario Budget.

We can do better.
