Subject: Waste Electronic recycling program and authorization for participation.

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby agree to enter into an arrangement with Redi Recycling Inc. for the removal of Waste Electronics effective immediately.

Further to our discussions, I have the following to provide with respect to the services offered by Redi Recycling Inc.

Redi Recycling is an approved collection operator under the Ontario Electronic Stewardship Program. As part of the OES program, we would look to invite your community to become a part of the Redi Recycling collection network in order to serve your residents. Redi Recycling uses Dumpy'z Ltd to provide bins and transport services and would come to your site to recover the electronics you manage within your electronics diversion program. There is no cost to this service as it is all managed within the OES program provided we put in place the required permission letters between ourselves.

To that end, in order to have the Townships of Head, Clara & Maria be part of the system, I would require your agreement to allow us to place a bin on your site to collect WEEE (Waste Electrical and Electronic Equipment). In the letter, we would need to specify the address location, I have attached a sample that Bonnechere Valley did for your reference. As well, I understand you are holding some electronics now so when we bring the 10-yard roll-off bin this material can be placed into it and then used to store the electronics in the future.

Should you and your Council agree to work with Redi Recycling, I will coordinate to have your site added to my network and promoted to your residents by listing it on the OES Recycling Your Electronics website. <http://www.recycleyourelectronics.ca/> I will provide you with quantities diverted and also coordinate the provision of brochures for distribution to residents that use site or visit your town hall. On a final note, I would provide support to your staff by training them on handling techniques for WEEE management as required. As discussed, as an OES service provider, we do not charge for any electronics managed within the program including TVs in wooden cabinets. As for products not in the program, such as white goods and microwaves, these can typically go into your scrap metal pile for recycling.

For your information, Redi Recycling offers this service at not cost to you as we will be compensated for the WEEE it recovers from your site as well as for the stacking, wrapping, labeling and administrative reporting activities to the OES program. At this time, I would like to let you know that you can become an approved operator within the OES program should you choose to do so. But I do hope that you decide to work with me to become part of the broader Redi Recycling family that includes Bonnechere Valley, Madawaska Valley, Killaloe Hagarty & Richards, Brudenell Lyndoch & Raglan and McNab Braeside. I would also like to note that if you become part of our network, I would be able to provide battery-recycling services for any alkaline, lithium, button cell and NiCad batteries. Simply place all batteries into a 5-gallon plastic pail with lid and when full we can coordinate pick up when we switch out the electronics bin.

Recycling electronics just got easier.

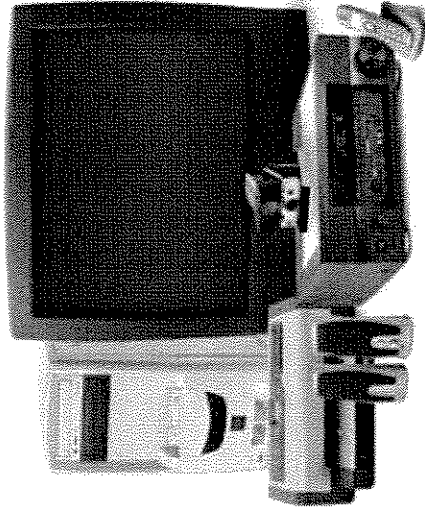
Ontario Electronic Stewardship has set up a network of more than 600 approved collection sites across the province where Ontarians can bring their used, obsolete or unwanted electronic equipment for responsible reuse and refurbishment or safe, secure recycling.

The reason is simple – to recover what can be used again, and safely manage hazardous materials which should never go to landfill.

Where do I take them?

Right now you can bring your used electronics to a variety of municipal, not-for-profit, retail and other types of depots and special event days. Ontario Electronic Stewardship (OES), the not-for-profit organization charged with implementing this program, is continuously working to set up more collection locations in your area. From there, these items will either be reused or recycled in an environmentally responsible way.

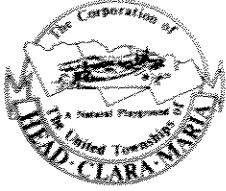
Who is funding this program?

The program is funded by fees paid to OES by manufacturers and importers of electronics in Ontario (called Stewards). These funds are used exclusively to pay for collection, transportation, consolidation, and processing of waste electronics as well as research and consumer education programs to encourage greater electronic equipment reuse and recycling.

In some cases, Stewards absorb the fees they pay to OES. In others, Stewards may choose to reflect these costs at the point of purchase. The fees are used exclusively to promote and support the safe and responsible reuse and recycling of electronic waste in the province. None of the funds go to government.
