THEREFORE BE IT RESOLVED THAT THE Council of the United Townships of Head, Clara & Maria does fully understand the implications of obtaining a permanent liquor sale license under the *Liquor License Act* including benefits, challenges and costs involved and does hereby authorize staff to proceed with application for a permanent liquor sales license for the community centre in Stonecliffe;

AND FURTHER directs staff to arrange that a staff member or qualified volunteer be on site during the entirety of any Special Occasion Permit licensed event to ensure that municipal policy is being followed and to document any incidents which occur;

WHEREAS the importance of social interaction, general activity and physical recreation are important in the development, health and well-being of young and old alike;

AND WHEREAS the Council of the United Townships of Head, Clara & Maria recently leveraged Federal grant monies to update the community centre into a well-equipped facility for recreation;

AND WHEREAS Council further budgeted up to \$7,500 for recreation purposes for the 2014 budget year;

NOW THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby authorize staff to research various options for increased useage of the recreation facility;

AND FURTHER THAT a General Facility Use Policy and amended Fee Schedule be created to encourage use by residents and ratepayers as well as those outside our community;

AND FURTHER THAT Council does commit \$500 from its recreation budget towards this project and authorizes staff to work with volunteers to organize and manage the event.

THEREFORE BE IT RESOLVED THAT for ease of completing Council approved purchasing the Council of the United Townships of Head, Clara & Maria does see the benefit in increasing the credit card limits and does hereby authorize that the credit cards for the Clerk and Treasurer be increased to a limit of \$5,000 and \$10,000 respectively.

AND FURTHER THAT a contribution towards costs in the amount of \$250 be provided to organizers recognizing that a full accounting will have to be provided to the Treasurer upon completion of the event.

WHEREAS the *Municipal Elections Act* requires each municipality to have a Compliance Audit Committee to sit for the term of council and to decide whether election finance complaints have merit warranting further investigation by an auditor;

AND WHEREAS these important committees require individuals with training, expertise, dedication and commitment which may be difficult to locate in some areas as there are restrictions on who may sit on the committee;

AND WHEREAS after the 2010 election not one of the county municipalities required the services of an Elections Compliance Audit Committee but each used valuable time and resources to create, train and manage one;

THEREFORE BE IT RESOLVED THAT THE Council of the United Townships of Head, Clara & Maria does hereby call on the Council of the County of Renfrew to upload the creation, training and management of an Election Finance Compliance Audit Committee which would be available to provide services to any lower tier municipality within the County;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby agree to remove section 2.2 ensuring that a Procedure By-law is always and continuously in place as per the *Municipal Act*;

AND FURTHER THAT section 25.4 and 25.5 be amended ensuring that there is one consistent order of voting during recorded votes by removing the words:

_____ “must vote in alphabetical order” in section 25.4 **or**

X “The presiding officer shall vote last” in section 25.5.
