**MUNICIPAL OFFICE CLOSED THURSDAYS**

Beginning June, 2014 the **Municipal Office will be closed every Thursday**. Staff will be at work but will not be answering the door, phone or emails. Office doors will be locked. The purpose is to provide a period of time to routinely work on projects which require concentration; where interruptions, no matter how important, prevent progress. Such projects would include tasks such as grant applications, policy, by-law and contract review or creation, bank reconciliation, tax calculations and training.

Council has authorized this closure for a trial to determine if productivity can be improved in this manner. A review will take place at year end where the outcomes and practise will be reassessed.

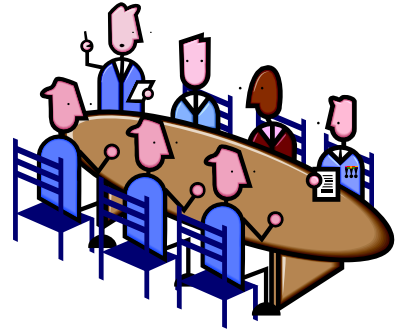

**DIGITAL CANADA 150**

“Connecting Canadians is about ensuring that Canadians, wherever they live, have access to the latest wireless technologies and high-speed networks at the most affordable prices possible. Through Connecting Canadians, the Government of Canada will invest \$305 million to extend access to broadband Internet at 5 megabits per second (Mbps) to 98% of Canadian households, mainly in rural and remote communities. The Government will issue a call for applications this fall. Following the application process, the Government will work with Internet service providers

to extend affordable, high-speed broadband Internet to households in need.”

The government is asking “providers to **provide feedback online** to help better determine where there are households that could be eligible for funding. In the fall of 2014, the updated coverage maps will be used to identify places that are most in need of investment.

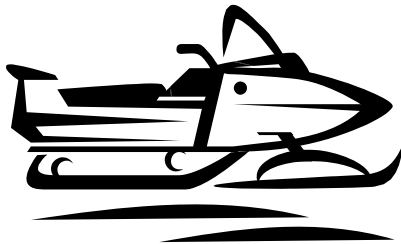

**Deadline is Fast Approaching!**

**Nominations** for the offices below may be made by completing the prescribed form and filing it in the office of the Clerk, accompanied by filing fee of \$200 for the Head of Council and \$100 for all other offices. The filing fee is payable by cash, debit, certified cheque or money order.

A nomination must be signed by the candidate and filed in person or by an agent during regular business hours (8:30—4:00—Monday—Wednesday and Friday) until September 11, 2014 and between 9 a.m. and 2 p.m. on **September 12, 2014 (Nomination Day)**.

**Reeve—One to be elected at large**

**Councillors—Four to be elected at large**

In the event that there are an insufficient number of certified candidates to fill all positions available, nominations will be re-opened for the vacant positions only on Wednesday, September 17, 2014 between the hours of 9 a.m. and 2 p.m. and such additional nominations, if required, may be filed in the office of the Clerk.

## MUNICIPAL ELECTIONS 2014

If you'd like to become a member of Council, or if you are simply wondering who to vote for...perhaps you might first ask and answer the following questions.

### Have I? Have they? Will I? Will they?

- ...competently and professionally fulfill the responsibilities of office? Make sure to understand the responsibilities of office?
- ...diligently attend all meetings to the best of your abilities?
- ...regularly participate in decision-making process, except when a conflict prohibits participation?
- ...become knowledgeable on all issues before Council?
- ...always exercise independent judgment?
- ...ignore staff recommendations and substitute personal judgment? Or that of a lobbyist?
- ...personally investigate issues?
- ...act with integrity and honesty?
- ...truly care about the future of the community and act accordingly?
- ...be in it for personal gain?

### Other Considerations...

- When, and how, can you seek outside advice or counsel on an issue?
- Do your constituents deserve a public explanation on all votes cast or decisions you have made?
- Is it ethical to delay a decision or confuse an issue because of outside pressures?
- Were you elected to use your best judgment?
- Were you elected to represent the views of the majority of your constituents?
- Were you elected to represent the views of those who voted for you?
- Is it permissible to introduce an issue solely to create a record for your campaign?
- Is your first commitment to consider the needs of your community, municipality, province or nation?
- Should you remain independent when joining others may be more conducive to achieving policy goals?
- Should you ever exchange promises to vote for another's proposed legislation in return for their promise to vote for yours?
- What are your obligations to subsequently follow the rule of the majority when you argued for an opposite result?
- Are you respectful of staff roles, responsibilities, and time?
- Should you be a whistle blower even if means potentially derailing a policy objective you are pursuing?
- When you speak with the press do you distinguish between official representations and personal views? Should you?

1. On Wednesday, August 27 at 6:00 p.m. in Petawawa, our representative from the Ministry of Municipal Affairs and Housing will be holding an information session on being on Municipal Council. We encourage anyone thinking of filing whether experienced or not to attend. Contact the office for car-pooling info.
2. Prior to each Council meeting we are showing a series of talks by George Cuff, an expert in municipal governance. Join us for the next session at 1:00 p.m. on Friday, August 22, 2014.
3. An on-line course created by AMO is available at <http://www.amo.on.ca/amo-content/events/so-you-want-to-run-for-council.aspx>. This course will provide an overview of what you need to know to before you decide to run for municipal office and what you should know to begin your candidacy. **Cost:** \$24.95 gets your 30 days access to a wealth of knowledge
4. The municipal office has a number of books which you may borrow outlining what municipal governance is and describing how to run a successful campaign.

## A MESSAGE FROM OUR TREASURER

### New payment option available for HCM invoices/property tax payments.

1. **ON-LINE**—HCM now has a new online payment option, **ePay for PayPal**. You register, by going on HCM website at <http://www.townshipsofheadclaramaria.ca/> and click on **make an ePayment**.

Follow the instructions provided. Once all information is submitted, you will receive an eCommerce Account Verification email. Follow instructions once again, then you will be on your way to **pay an invoice** (*tipping fees and building permits*) or a **property tax payment**.

**To pay an invoice:** enter your invoice number (*top right hand corner of invoice*), and the amount to pay. A convenience fee (*see note below*) will be displayed and if you agree with the transaction, click to make a payment, it's that easy.

**To pay property taxes:** enter your roll number (*4798 #.*), amount to pay, and follow same process as paying an invoice.

The ePay for PayPal option provides a more flexible electronic payment solution for Visa, MasterCard, Discover, American Express and PayPal users.

**Please note:** This payment model, calculates and charges a convenience fee to the paying customer which covers the credit card processing fees. All convenience fees go USTI Canada.

2. **BANK BRANCH**—Scotiabank tax bill payments:

You may go directly to a Scotiabank branch and pay your tax bill.

Ensure you have your tax bill with you.

If you are **not a Scotiabank customer**: let the teller know that you wish to make a payment as a non-customer and he/she will know the process to follow. If there are challenges, advise the teller to drop the first 4 digits of your roll number (4798) and the payment should proceed. If there are still issues, have the teller call our township office (613-586-2526) and we will be able to walk them through the process.

If you are a **Scotiabank customer**: you are able to pay **tax bills** on-line by adding Head Clara Maria as a payee. When you enter the account # to register your roll number as a payee, drop the 4798 from the beginning.

**Please note:** When making payments in person at a branch, Scotiabank **only** accepts Visa, Debit, **Scotiabank cheques** and cash payments.

3. **MUNICIPAL OFFICE:**

15 Township Hall Road, Stonecliffe, Ontario, K0J 2K0. We accept cash, cheque or money order payments for all invoices and property taxes. If you are not able to attend during office hours, payments may be dropped off after hours at the municipal office entrance thru the mail slot or mailed.

If you have any questions or concerns, please contact our office. Office hours are Monday – Wednesday & Friday, 8:30 am to 4:00 pm. Please keep in mind, our office is **closed** on Thursdays and phones/emails will not be answered.

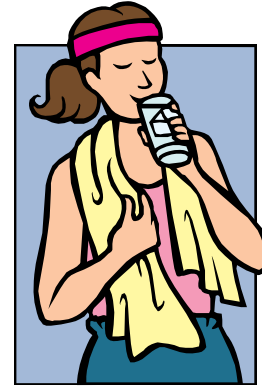

## SUMMER SAFETY

GIANT HOGWEED  
*HERACLEUM MANTEGAZZIANUM*

For clear photos please go on-line or stop by the municipal office. If you think you have located Giant Hogweed, please seek help from a professional exterminator.

**Giant Hogweed** (*Heracleum mantegazzianum*), also known as Giant cow parsnip is a perennial plant and a member of the carrot family. It is a garden ornamental from southwest Asia that is naturalizing in North America and becoming more common in southern and central Ontario. Giant Hogweed has the potential to spread readily and grows along roadsides, ditches and streams. It invades old fields and native habitats such as open woodlands.

**Similar Species**

There are a number of plants that look very similar to Giant hogweed such as Cow parsnip, Purplestem angelica, Woodland angelica, Valerian, Lovage, and Queen Anne's-Lace (also known as Wild carrot). However, these plants are not as large as a mature Giant hogweed, which grows up to 5.5 metres tall under ideal conditions. The white flower clusters resemble those of Queen Anne's-Lace, but tend to be more widely spaced and can form a flower-head almost one metre wide. Check out the [Giant Hogweed and Look-a-Likes](#) resource to see the differences.

**Health Concerns**

The clear watery sap of Giant hogweed contains toxins that can cause severe dermatitis (inflammation of the skin). You can get severe burns if you get the sap on your skin and the skin is then exposed to sunlight. Symptoms occur within 48 hours and consist of painful blisters. Purplish scars may form that last for many years. Eye contact with the sap has been reported (in the media and by various web sites) to cause temporary or permanent blindness. However, evidence of permanent blindness linked to exposure to Giant hogweed cannot be substantiated by any existing research. Coming in contact with Cow parsnip and Wild parsnip can cause similar reactions.

**Removal and Management**

If you have Giant hogweed on your property, it is recommended that you hire a professional exterminator to remove it. The plant will be removed safely and as few seeds as possible will be spread. Reducing a large population of Giant hogweed will take a long term commitment. The best time to remove the plant is in late April or early May. It is usually less than 30 centimetres tall, easier to dig up, and more susceptible to herbicides at this time of year. It is also cooler in the spring than in the summer so wearing protective clothing is more comfortable.

## MMAH'S MUNICIPAL COUNCILLOR GUIDE CONTINUED

### Council-Board Relations

Local boards and other special purpose bodies have varying degrees of independence from municipal council control. Some local boards may be mandatory (i.e., legislation may require that they be in place when certain services are chosen). Police services boards and

public library boards may be mandatory in this sense. Other local boards, including municipal service boards, are optional (i.e., your council may set them up at its discretion); once established, however, their operation must comply with relevant statutes.

Some boards or bodies may be beyond effective control of council for practical or legal reasons. Bodies such as school boards, hospital boards,

boards of health, conservation authorities, and district social service administration boards, for example, generally operate quite independently of council. The school boards operating in your municipality are independent of your council and have their own elected governing bodies. In the school context, the general role of municipalities is to run school board elections and collect school taxes.

You should become familiar with the responsibilities of local boards and other special purpose bodies serving your municipality and be aware of their relationship to council.

### Municipal Associations

The Municipal Act, 2001 recognizes municipalities as responsible and accountable governments and endorses the principle of ongoing consultation between the provincial government and municipalities on matters of mutual interest. Subsection 3(1) of the act requires the provincial government to consult with municipalities in accordance

with a memorandum of understanding (MOU) entered into between the provincial government and the Association of Municipalities of Ontario (AMO).

The MOU provides for consultation between the provincial government and AMO when the government is proposing a change in legislation and regulations that will, in the provincial government's opinion, have a significant impact on the current municipal budget or budget cycle. The MOU also provides for provincial consultation with AMO on the negotiation of certain agreements between Canada and Ontario that have a direct municipal impact.

AMO is a non-profit organization that represents almost all municipalities in the province. AMO provides a variety of services – including the gathering and dissemination of information, policy development and inter-government relations.

**CONDUCT OF MEMBERS

**Cont'd**

No person except members and Officers of the Council shall be allowed to come to the Council table during the sittings of the Council without permission of the Presiding Officer to do so.

When the chair is putting the question, no member shall leave the table or make a disturbance.

**OTHER COMMITTEES**

Insofar as possible, the procedures of the committees shall be the same as those set out for Council, unless otherwise prescribed by statute or law; it being understood that Committees act in an advisory capacity only and that unless decision making authority has been delegated by Council, motions presented and resolutions passed at the Committee level shall be deemed proposals and recommendations respectively.

The purpose, composition, jurisdiction, term and support staff assigned to any committee shall be as stipulated in the by-law or resolution establishing that Committee.

Standing, Advisory and Ad-hoc Committees wholly within the sphere of jurisdiction of Council may be established, revised, dis-

banded and replaced, as Council deems necessary.

The Council may, by By-Law or resolution, appoint any of its members or non Council members to standing, special or ad-hoc committees of Council.

Immediately after committee members are appointed, each committee shall meet briefly to appoint a chairperson from among themselves, unless otherwise specifically stipulated herein.

The Head of Council will be deemed to be an ex officio member on all committees where not otherwise prohibited by any Act and shall have full voting privileges when in attendance at any meeting thereof but shall not have the privilege of raising new business or adding any matter to a previously completed meeting Agenda. The Head of Council, in this capacity, does not count towards the determination of a quorum.

Should one be created, the main purpose of a Standing Committee is to oversee the operations of one or more municipal departments as well as to make recommendations to Council on policy matters referred to them. All provisions of this by-law shall apply to Standing Committees of Council.

**SPECIAL/AD HOC COMMITTEES**

Special/ad hoc committees shall be constituted for the purpose, and members named, as expressed by resolution of Council. The Head of Council shall be an ex-officio member and in this capacity will not be included in determining a quorum.

If no time limit is set for dissolution, a special/ad hoc Committee shall be dissolved upon the ac-



ceptance of its final report by Council and at the end of the term of Council.

Meetings shall be called as designated by Council, or at the call of the committee chairperson.

Committees appointed to report upon any subject referred to them by the Council shall report their findings and their opinion thereof in writing in the form of minutes and resolutions passed in duly conducted meetings of committee. No minutes shall be received by Council unless signed by the secretary and chair of the committee.
