Under Ontario Works, recipients may receive assistance for special services, items or payments as a discretionary benefit. Eligibility for Ontario Works discretionary benefits is determined on a case-by-case basis at the discretion of the local Ontario Works Administrator.

**Subject:** Algonquin Land Claim

*The following memo is being sent on behalf of Brian Crane, Ontario's Chief Negotiator for the Algonquin Land Claim.*

Results of the Algonquins of Ontario ratification vote on the Proposed Agreement-in-Principle are now publicly available. They are posted on the Algonquins of Ontario website at: [http://www.tanakiwin.com/wp-system/uploads/2015/11/AOO-Media-Release\\_AIP-Ratification-Vote\\_20160317\\_Final.pdf](http://www.tanakiwin.com/wp-system/uploads/2015/11/AOO-Media-Release_AIP-Ratification-Vote_20160317_Final.pdf)

These results are now under the review of the three negotiation parties. Ontario is encouraged by the ratification vote results and we continue to hope for a common agreement by all three parties to move forward with these negotiations.

We have also received the results of a separate, parallel referendum that was conducted by the Algonquins of Pikwakanagan First Nation. This was an initiative managed by Pikwakanagan in order to facilitate the participation of a significant number of their membership who had not enrolled for the Algonquins of Ontario ratification vote process. The Pikwakanagan referendum results suggest some concern exists within that community.

At this time, we need to respect the needs of the Algonquins of Pikwakanagan and allow sufficient time for their leadership to determine the best way forward for that First Nation Community.

Ontario remains committed to working with the Algonquins of Pikwakanagan First Nation, and the other Algonquins of Ontario communities, to build on the common understandings and positive relationships that have been forged to date as a result of these negotiations.

Further information about the future of the negotiations will be provided once the necessary and appropriate discussions have taken place amongst the parties.

Re: Resolution – Overview of the 2015 Annual Report of the Auditor General

The City of Stratford has been working with the Social Assistance Management System (SAMS) computer system since it was implemented on November 11, 2014 which has proven to be a challenging endeavor for staff and clients alike.

The Ministry of Community and Social Services brought in PricewaterhouseCoopers (PwC) as an independent third-party advisor on March 2, 2015 to evaluate, advise and assist with the implementation of SAMS and received their final report including 19 recommendations to improve the SAMS transition on April 30, 2015.

The City of Stratford received the 2015 Annual Report of the Auditor General in which five recommendations were made to the Ministry of Community and Social Services to further improve the Social Assistance Management System:

Recommendation 1:

To ensure that eligible individuals receive the level of social assistance and support to which they are entitled, and to eliminate as best as possible, eligibility and benefit payment errors made by the Social Assistance Management System (SAMS), the Ministry of Community and Social Services should:

- assign adequate resources to review the backlog of information related to potential defects so that defects can be prioritized for fixing;
- allocate its resources so that fixing of defects takes priority; and
- develop a process to reconcile all benefit payment errors generated by SAMS to the eligible amounts that clients should have received and ensure that they are corrected.

Recommendation 2:

To prevent unnecessary delays in bringing the Social Assistance Management System (SAMS) to full and effective functionality, and to ensure that the consultants still working on SAMS are held accountable for delivering quality results, the Ministry of Community and Social Services should:

- assign its own properly qualified staff to directly oversee consultants;
- ensure that consultants' work is assessed for efficiency and effectiveness; and
- on future projects, work towards reducing its dependence on consultants, and ensure consultants' knowledge is transferred to ministry staff.

#### Recommendation 3:

To ensure that ministry staff can help fix all defects in the Social Assistance Management System (SAMS) in the short term, and maintain SAMS in the long term after consultants have left, the Ministry of Community and Social Services should:

- establish a knowledge transfer strategy for ministry staff which includes outcome targets based on achieving learning objectives; and
- assess and document the progress in achieving these targets.

#### Recommendation 4:

To ensure that the Social Assistance Management System (SAMS) reaches the high level of performance intended and that it functions in compliance with government requirements, the Ministry of Community and Social Services should ensure that SAMS undergoes and passes all government-mandated payment testing.

#### Recommendation 5:

In order to improve the decision-making process used to launch a major information system, the Ministry of Community and Social Services should:

- ensure that the decision to launch an information technology system is based on relevant criteria and information that provides decision-makers a complete and accurate status of system readiness; and
- have Internal Audit independently review key information used in assessing the system's state of readiness while making the decision to launch.

After consideration of the Auditor General's Report and staff report, Stratford City Council recently adopted the following resolution in regards to the ongoing issues involved with the implementation of the Social Assistance Management System (SAMS):

**NOW THEREFORE BE IT RESOLVED** That Council receives the information on the Auditor General's 2015 report in which five recommendations were made to help the Ministry of Community and Social Services further improve SAMS;

**BE IT FURTHER RESOLVED** That City Council requests from the Ministry of Community and Social Services, both a timeline and a plan for how the Ministry intends to implement the Social Assistance Management System recommendations from both PricewaterhouseCoopers (PwC) and the Auditor General of Ontario in order to provide a permanent fix to the SAMS system;

**BE IT FURTHER RESOLVED** That this resolution be forwarded to other Municipalities for their support, in writing to the Minister of Community and Social Services.

On September 25, 2016 Laurentian Hills is hosting the 5<sup>th</sup> annual Kitchissippi (Big River) Run in support of the North Renfrew Long-Term Care Centre and the Deep River and District Hospital Foundation. **Re: Update on the Energy East Pipeline Project and Re-opened Application to Participate**

As mentioned to you in previous correspondence, TransCanada filed an amended Application for the Energy East Pipeline Project to the National Energy Board (NEB) in December 2015. I am writing to share a further update on Energy East that occurred since that filing and to let you know about the next steps for the project.

As you may be aware, the federal government announced interim measures for its review of the Energy East Pipeline Project that will extend the overall regulatory timeframe to 27 months. We are currently reviewing this development and assessing the potential impact on the project.

**While we await the results of the NEB's review of the Application, I would ask that you direct all inquiries about the Energy East Pipeline Project to me directly. I will be more than happy to answer any questions you may have, as well as share the latest information on Energy East.**

The NEB has also opened a supplemental Application to Participate process for those directly affected or who may have relevant information or expertise related to the amendments. The online Application to Participate form will be available on the NEB's website for a period of three weeks, starting March 30 to April 20, 2016. **The deadline to submit an Application to Participate is April 20, 2016 at Noon Mountain Standard Time.**

If you previously applied to participate, you need not apply again. Your original Application to Participate remains valid and will be considered by the NEB. Here is the link to the NEB's website to submit an application:

Going forward, we have indicated to the NEB that we will be filing a Consolidated Application at the end of April in response to their request. This consolidation is a clean version of the Application and will incorporate the various supplemental and amendment filings that have been submitted to date.

We value each and every one of the communities that we pass through and want to keep the communication lines open. We will also be present at many municipal conferences across Ontario this year including FONOM, AMO, NOMA, and OEMC. We plan on having technical experts on hand to help answer any questions you may have.

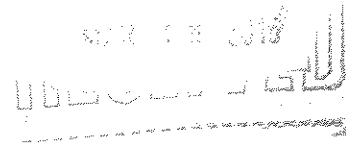

Re: **Richmond Hill Town Council – Ontario Municipal Board Reform**

Richmond Hill Town Council, at its meeting held on February 22, 2016, adopted the following resolution:

"Whereas the Town of Richmond Hill has dedicated a good deal of time, and resources, developing an Official Plan that guides and directs the future development of our community and accurately reflects the expectations of the citizens of Richmond Hill; and

Whereas the Town of Richmond Hill also spends a good deal of resources defending the Official Plan and our Zoning By-laws at the Ontario Municipal Board (OMB); and

Whereas the Town's Official Plan is ultimately approved by the Ontario Provincial Government; and

Whereas it is within the legislative purview of Municipal Council to rule on Official Plan amendments or Zoning By-law changes that better the community or fit within the vision of the Town of Richmond Hill Official Plan; and

Whereas it is also within the legislative purview of Municipal Council to deny Official Plan amendments or Zoning By-law changes that do not better the community or do not fit within the vision of the Town of Richmond Hill's Official Plan; and

Whereas land use planning decisions may be appealed to the OMB, an unelected, appointed body that is not accountable to the residents of Richmond Hill;

Now therefore be it resolved that Richmond Hill Town Council requests the Government of Ontario thoroughly review the land use appeals process and develop a process for such appeals that recognizes and supports the rights of municipalities to make decisions that adhere to Municipally approved Official Plans, local community needs and aspirations, reflected in those plans; and

Be it further resolved that the regulated timelines before an appeal is possible based on a "failure to make a decision" by the municipality be significantly extended thus ensuring that:

1. Adequate time be given for proper and meaningful negotiations between the Municipality and Applicant with the goal of resolving planning disagreements
2. Applicants are prevented from appealing to the OMB before a thorough negotiation process has been exercised to come to a successful outcome

Be it further resolved that a copy of this Motion be sent to the Honourable Kathleen Wynne, Premier of Ontario; the Honourable Ted McMeekin, Minister of Municipal Affairs and Housing; the Honourable Patrick Brown, Leader of the Progressive Conservative Party; the Honourable Andrea Horwath, Leader of the New Democratic Party; all MPPs in the Province of Ontario; the Regional Municipality of York and all York Region Municipalities; and

Be it further resolved that a copy of this Motion be sent to the Association of Municipalities of Ontario (AMO) and all Ontario municipalities for their consideration."

In accordance with Council's directive, the foregoing Council resolution in this regard has been forwarded to your attention.

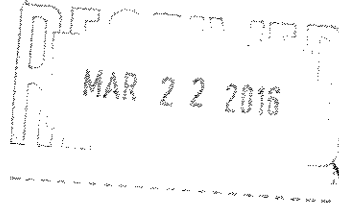

**April 1, 2016 - 1:30pm**

**MNRF Update: Christina Davis**

1. MNRF Current Situation:
  - Balaclava Dam: still monitoring, no operations, normal high freshet levels
  - Lake Dore Dam: log operations this morning, normal high freshet levels
  - Rivers and lakes: ice covered lakes, rivers full and flowing
  - Fraser Township snow station: no update
  - Snow levels: snow has gone down since Wednesday, more in open areas, fields completely open
2. Pembroke District Flood Status: A Flood Warning was issued for the Bonnechere River below the Town of Renfrew to the Ottawa River and a Flood Watch for Round Lake, Golden Lake and the remainder of Renfrew County on March 30, 2016.
3. Neighbouring District Status:
  - North Bay: flood watch for the southern portion issued on March 31
  - Bancroft: flood watch issued on March 30
  - Kemptville: water safety issued on March 24

**Surface Water Monitoring Centre Weather Forecast: Lak Ramanathan**

- Temperatures dropping over the next few days
- Nights below 0°C
- Days 0 to -5°C
- No precipitation forecast over the next few days – if any it will be snow
- Monday there is a possibility of a bit of snow

**Madawaska Update: Marc Bisson, OPG**

- No new snow information
- Bark Lake and Kamaniskeg Lake inflows are rising rapidly
- The flow on the Madawaska has doubled
- Expecting Kamaniskeg Lake to peak on Sunday or Monday

**Ottawa River Update: Michael Sarich, ORRS**

- Northern reservoirs have flattened off, not expecting flows from the north to increase after this past week's rain event
- Tributaries in the middle are rising
- The rise is slowing in the southern tributaries, peaks on the lower tributaries were less than expected
- Levels will still rise but only to the start of flooding levels

## **Bonnechere River Update**

1. Round Lake & Golden Lake: Shawn Cameron, RPG
  - Golden Lake has exceeded its upper Water Management Plan limit
  - Round Lake is still rising and hasn't crested yet
  - At Renfrew the flows have tripled
  - The Bonnechere system is quite full
2. Eganville: Jack Roesner, Eganville Generation Corp.
  - Since Wednesday there has been a steady increase in the water level but it is still manageable by raising the gate every day
3. Douglas: Shawn Cameron for Janusz Rydel, Multistream Power Corp.
  - Lots of water but manageable

## **Office of the Fire Marshall and Emergency Management: Philippe Geoffrion**

- Monitoring the South West Ontario situation

## **County of Renfrew: Steve Bolan**

- On Highway 58/Round Lake Road the water in the Indian River is still well below the bridge at the Alice Ski Hill
- Levels at or close to normal for this time of year

## **City of Pembroke: Doug Sitland**

- Indian River: ice free, no debris, flowing well
- Muskrat River: no concerns, water is up a bit at the Bishop Smith foot bridge but the water is clear of debris so no problems

## **Other Townships/Municipalities or others:**

- Town of Renfrew: Mike Asselin
  - Lots of water passing on the Bonnechere River
  - Higher backwater than normal at the sewage pumping station
- Township of Laurentian Valley: Lauree Armstrong
  - The Indian River is high but manageable
