It has come to the attention of municipal administration that over the years you have continued to groom the unopened road allowance adjacent to your property on Harvey Creek Road in Mackey by cutting grass and creating a lawn. It is our understanding that you have been using municipal property despite the letter send in 2006, a copy of which is enclosed for your reference.

Please be advised that such use of municipal property by a private property owner is not permitted.

Further, this situation has been brought to our attention due to a recent decision by Council to provide access to the Ottawa River by the public along this unopened road allowance.

Please be advised that municipal staff and contractors will be working on this municipal property in the near future as per the decision of council made at their meeting on Tuesday, June 20, 2018 to widen the access and create a parking spot for the public.
