Good morning Hope,

We do not carry the official road signs because we aren't permitted to install them. The only way to get signs posted on any road is by going through your local municipality or government. You could also try the Ministry of Transportation. We have heard that people have better luck if they approach with some statistics or photos to show why the signs are needed.

Signs may be purchased either through BMR Manufacturing in Campbellford, or via Toronto Zoo's Adopt-a-Pond program. The signs are about \$50.00 which includes the mounting hardware but not the post - the municipality's posts must be used.

Hi Crystal,

The ministry does not install 'turtle crossing' warning signs on provincial highways. However, we do occasionally install 'wildlife mortality awareness' signs (see attached).

If you send me more details regarding the two Hwy 17 locations, the ministry can begin the process of determining whether or not these signs qualify for installation (based on the criteria outlined in our policy).

'Wildlife mortality awareness' signs are considered in areas identified as a mortality hotspot. These locations must be verified to support the presence of regulated species at risk (protected under the Endangered Species Act). In addition, wildlife in these areas must live adjacent to the ministry right-of-way and habitually cross the highway (as established through monitoring and field investigations).

We have has a request from a resident who would like the municipality to install turtle crossing signs in two areas along Highway 17.

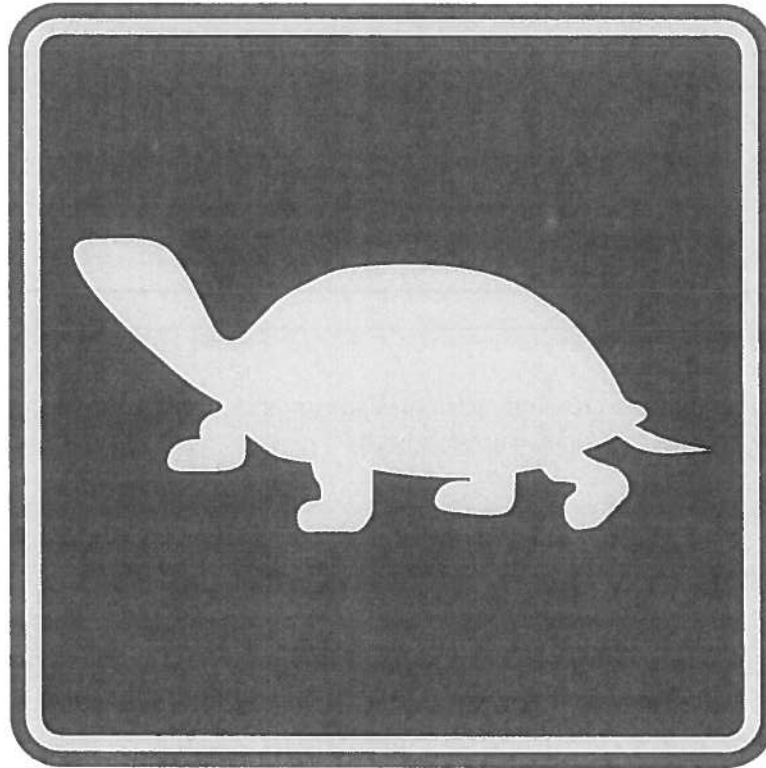

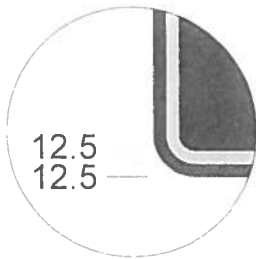

Eastern Ontario Regional Network's Mobile Broadband Project

I am writing to you today on behalf of the County of Renfrew regarding the urgent need for the Federal Government of Canada to officially commit funding to the Eastern Ontario Regional Networks' Mobile Broadband Project.

One of the key requirements for Federal participation was the nomination of the Project by the Province of Ontario to Canada. We understand that necessity was fulfilled this past April via a letter from the Deputy Minister of Infrastructure to his counterpart in the Government of Canada.

On May 17th the Honourable Monte McNaughton, Minister of Infrastructure for the Province of Ontario announced their \$71 million share of EORN's mobile broadband project and the commitment of municipalities across eastern Ontario of the local share in the amount of \$10 million all that remains to move the project forward is confirmation of your government's share.

On May 29, 2019, the County of Renfrew passed the following resolution:

WHEREAS on May 17, 2019 the Honourable Monte McNaughton, Minister of Infrastructure for the Province of Ontario officially announced confirmation of Ontario's \$71 million contribution to the Eastern Ontario Regional Networks Mobile Broadband project;

WHEREAS nine separated municipalities including the cities of Kingston, Peterborough, Belleville, Cornwall and Quinte West who represent a further 378,000 urban residents are supporting the project and have agreed to pay their portion of the \$10 million local contribution;

AND WHEREAS the Eastern Ontario Wardens' Caucus who represent 110 municipalities and 750,000 rural residents of the region have committed \$10 million as a local contribution towards the project;

NOW THEREFORE be it resolved that the Eastern Ontario Wardens' Caucus calls upon the Federal Government to formally commit \$71million towards the Project and instruct Federal staff to begin discussions on the necessary contribution agreement(s), before the House of Commons rises in June;

AND FINALLY THAT our local Federal Members of Parliament be copied with this resolution and seek their support to work with the EOWC and its partner municipalities to secure the Federal contribution.

Minister, supporting EORN's mobile broadband project just makes good economic sense and is the key to our region's future growth. A prosperous eastern Ontario will contribute to Canada's national economy.

We need the Federal Government to join with the Province of Ontario and the 113 municipalities that make up Eastern Ontario to bring this project to life. This is one of those moments in time when governments at all levels can come together for the people of our region and their future.

As municipal leaders across Eastern Ontario we are saying, the time is now. The 1.1 million people who call our communities home need your Government's commitment of \$71 million to allow this essential economic and public safety project to move forward on an urgent basis.

Please be advised that Brantford City Council at its meeting held June 25, 2019 adopted the following:

Endorsement of LUMCO Resolution regarding Retail Cannabis Stores

- A. THAT the Association of Municipalities of Ontario (AMO) and the Premier of Ontario be advised that Brantford City Council ENDORSES the following Resolution adopted by LUMCO (Large Urban Mayors Caucus of Ontario) at its May 24, 2019 Meeting:

WHEREAS in April 2017, the Federal Government introduced Bill C-45, The Cannabis Act, and Bill C-46, An Act to Amend the Criminal Code, outlining plans to legalize, regulate and restrict access to cannabis in Canada; and

WHEREAS the Province of Ontario responded with corresponding legislation, the Cannabis Control Act, 2017, the Ontario Cannabis Retail Corporation Act, 2017, the Cannabis License Act, 2018, and Bill 36- Cannabis Statute Law Amendment Act, 2018; and

WHEREAS collectively, this legislation created a regulatory regime effective October 17, 2018 that allows Ontario residents who are 19 years of age or older to: 1. Purchase recreational cannabis online through the Ontario Cannabis Store 2. Possess up to 30 grams of cannabis 3. Grow up to four (4) cannabis plants per household 4. Purchase cannabis from a provincially approved private retail supplier as of April 1, 2019; and

WHEREAS municipalities across Ontario were given until January 22, 2019 to choose if retail cannabis stores will be prohibited within their borders and those that "opted out" may at a later date by resolution of their respective Council, lift the prohibition and permit them in the future; and

WHEREAS Ontario Regulation 468/18 permits limited municipal regulatory control over location and zoning, licensing and spatial separation to sensitive land uses other than a school as defined by the Education Act;

NOW THEREFORE BE IT RESOLVED THAT the Large Urban Mayors Caucus of Ontario (LUMCO) recommends that additional local regulatory controls be approved by the Province of Ontario around retail cannabis stores that would: A. Provide a municipality with the unrestricted ability to control the location of retail cannabis stores through zoning; and, B. In the alternative to A; 1) Limit the concentration and number of cannabis retail stores in any one municipality by introducing a minimum distance separation measure between retail stores (minimum 500 metres); and, 2) That cannabis stores be restricted to a Commercial Zone or Area which permits retail stores; and 3) Clearly defining sensitive land uses, in addition to schools, which would be impacted by having a retail cannabis store located adjacent to them. Such other sensitive land uses would include, but not be limited to, day cares, colleges and universities, community centres, nursing homes, libraries and actively programmed municipal parks; and, 4) That the current minimum distance separation of 150 meters from a cannabis retail store to a school be increased to a minimum of 500 metres from any sensitive land use to be defined as noted in paragraph 3 above; and C. That all municipalities that have approved retail cannabis stores to be located in their jurisdictions receive 50% of ALL excise tax collected by the Province of Ontario on the sale of cannabis; not limited to revenues in excess of \$100 million; and

THAT upon adoption of this Resolution by LUMCO, it be presented to all Ontario Municipal Councils with a request to endorse and that the municipally adopted resolutions then be forwarded to the Association of Municipalities of Ontario (AMO) and the Premier of Ontario's office;

Further, THAT members of the LUMCO Retail Cannabis Committee request a meeting with Minister Doug Downey regarding this resolution and to also request the AMO Board add this topic as an agenda item for discussion at the August 2019 AMO Annual Conference.

- B. THAT a copy of this Resolution BE FORWARDED to the MP and MPP Brantford-Brant, the Federation of Canadian Municipalities (FCM) and other municipalities in the Province of Ontario.

Dear Mayor and Council,

For the second time in three years, many communities and businesses in the Ottawa River and Great Lakes watersheds are experiencing flooding due to record-high water levels. Property owners, already out of pocket tens of thousands of dollars repairing their properties in 2017, now face the same situation in 2019. While provincial authorities are providing partial assistance to flood victims, there is a cap on losses.

As boundary waters, the Great Lakes and the Ottawa River fall under federal jurisdiction. The Federal Government should have realized before it signed Plan 2014 on December 8th, 2016, that raising the water levels in the Great Lakes Watershed could affect the Ottawa River flow. Three months later in 2017 the Ottawa River set high-water level records.

Regular flooding is intended by the current federal government as it implements “environmental flows”, and the re-creation of wetlands for its government climate change policy. As a consequence of amendments made to *the Fisheries Act*, contained in Bill C-68, spring flooding will be intentional to restore fish habitat. Of the 7 members on the Ottawa River Regulation Planning Board (ORRPB), 3 are appointed by the Federal Government. They should have been aware of the danger posed by these policies.

These changes are quite apart from the massive snowpack and likelihood of continued rains in the spring. Yet, rather than acting, the ORRPB continued the status quo, resulting in more flooding and more property damage along the Ottawa River.

The federal government must adopt a fairer course to ensure the protection of the public on both sides of the Ottawa River as well as the Great Lakes watershed, are the highest priority.

Please, join me in calling on the Prime Minister to do the right thing and provide federal compensation to all the victims of highwater caused by federal policies.

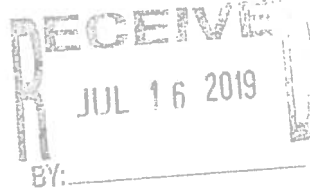

Dear Prime Minister,

For the second time in three years, many communities and businesses in the Ottawa River and Great Lakes watersheds are experiencing flooding due to record-high water levels. As a result, individual property owners, out of pocket tens of thousands of dollars repairing their properties in 2017, now face the same situation in 2019.

The Federal Government signed Plan 2014 on December 8th, 2016. Among the measures included were raising the water levels in the Great Lakes watershed. Three months later in 2017 the Ottawa River also set high-water level records.

Furthering the problem of high water are amendments made to the *Fisheries Act*, contained in Bill C-68, *An Act to amend the Fisheries Act and other Acts in consequence*, encourage spring flooding to restore fish habitat. As "environmental flows" are implemented for the re-creation of wetlands, regular flooding is expected, and intended.

While provincial authorities are prepared to provide partial assistance to flood victims, with a cap on losses, those programs discriminate between residents of different provinces and the types of dwellings.

In light of the devastating flooding occurring, the property owners require the federal government reimburse them for their costs and make additional funds available for mitigation projects and other protective measures made necessary through acts and omissions of the Government of Canada.

The Ottawa River Regulation Planning Board and the International Joint Commission must immediately recalculate the volume of water and the flow rate at which it can be safely released and release that amount. Finally, the ORRPB must immediately correct its water management protocols to avoid damage to riparian owners.

Your prompt response, prior to July 31st, 2019 is requested.

Mayor and Council,

As part of our economic development program, the County of Renfrew investigates corporate, cultural, entertainment and sports events that have a strong potential to be hosted in Renfrew County. Calabogie Peaks Resort suggested that an Ontario Winter Games could be hosted here with our many community and school arenas, swimming pools, gymnasiums, cross-country ski venues and the downhill skiing and snowboarding facilities at Calabogie Peaks.

County staff coordinated a first meeting of municipal recreation leaders from across the county and all were positive that, in partnership, we could meet the requirements to host an Ontario Winter Games in Renfrew County. With that expression of support, the County of Renfrew initiated the bidding process to host the Ontario Youth Winter Games in 2022 (OYWG 2022). To meet the requirements for sporting event venues, opening ceremonies, accommodations and meals our preliminary bid identifies potential facilities, businesses, food service and accommodation providers across Renfrew County. The Ontario Ministry of Tourism, Culture and Sport (MTCS) has accepted our preliminary bid for the OYWG 2022.

We are now seeking Letters of Support from municipal councils to demonstrate to the MTCS the support of municipalities for the hosting of the OYWG 2022. If successful, funds will be provided by the MTCS to cover the costs to deliver the games. This provincial funding is intended for hosting and feeding athletes and coaches, transportation, facility rental fees, equipment rental, promotions and marketing to deliver the games and the hiring of a General Manager to coordinate the games. The funding will be spread over many businesses, communities and recreation facilities and clubs across Renfrew County. The Ministry also encourages budgeting for a small surplus which would fund an Ontario Youth Winter Games legacy project in the county.

We anticipate 3,500 athletes and coaches participating in OYWG 2022, and many family members and spectators visiting to view the competitions. This will bring significant new business to all our accommodators, restaurants and retailers during what is typically a quiet business period, early March just prior to March school break. These athletes and visitors will be hosted across the county, utilizing sports venues and the businesses in almost every municipality.

This will be an exciting project, with positive impacts across Renfrew County, and the first time the Ontario Youth Winter Games have been hosted in Eastern Ontario. We look forward to your support and participation.

Resolution: Opposition to Changes in 2019 Provincial Budget and Planning Act

WHEREAS on April 11, 2019, the Provincial government tabled a new budget, some of which represents a significant shift in priorities, with direct implications to the City of Stratford and municipalities across Ontario;

AND WHEREAS this shift in priorities will put disproportionate pressure on municipal governments to either fully fund Provincially discontinued programs or partially supplement programs and services at current service levels;

AND WHEREAS the City of Stratford recognizes that the Government of Ontario announced in May 2019 that it will reverse mid-year cuts to critical services of public health, childcare and ambulance services and requests an opportunity to work collaboratively to find solutions that will work for all partners and protect services prior to drafting 2020 budgets;

AND WHEREAS previous legislation that abolished the OMB and replaced it with LPAT received unanimous – all party support as all parties recognized that local governments should have the authority to uphold their provincially approved Official Plans and community driven planning;

AND WHEREAS in the spirit of working together for the benefit of all Ontario residents, Stratford City Council opposes the upcoming changes to the Planning Act as municipalities were not consulted and afforded an opportunity to provide feedback;

AND REQUESTS a meeting with MPP Pettapiece, the Minister of Municipal Affairs and other related ministries on the effects of downloading onto municipal governments;

AND THAT this resolution be forwarded to all municipalities in Ontario and to AMO.

WHEREAS the Province of Ontario, through the Ministry of the Environment, Conservation and Parks, has posted a discussion paper entitled "Reducing Litter and Waste in our Communities";

AN WHEREAS producer responsibility has not been adequately addressed by the Province of Ontario;

AND WHEREAS a successful deposit/return program for single use plastic, aluminum and metal drink containers has been in existence in other Provinces in Canada including Newfoundland, Nova Scotia and British Columbia;

AND WHEREAS these successful program have eliminated many of these containers from the natural environment;

AND FURTHER THAT that the Province of Ontario review current producer requirements and look for extended producer responsibility for all packaging;

AND FURTHER THAT a copy of this motion be sent to the Premier of Ontario; the Minister of the Environment, Conservation and Parks; the Minister of Municipal Affairs; the Association of Municipalities of Ontario; the Region of Halton; and all municipalities in the Province of Ontario.

RE: Provincial Policy Statement Review – Draft Policies

I am writing today to announce that my ministry is launching a consultation on proposed policy changes to the **Provincial Policy Statement (PPS)**. The PPS is an important part of Ontario's land use planning system, setting out the provincial land use policy direction.

Municipalities play a key role in implementing these policies through local official plans, zoning by-laws and other planning decisions. The Planning Act requires that decisions on land use planning matters be "consistent with" the Provincial Policy Statement policies.

The government is consulting on draft policy changes to:

- Encourage the development of an increased mix and supply of housing
- Protect the environment and public safety
- Reduce barriers and costs for development and provide greater predictability
- Support rural, northern and Indigenous communities
- Support the economy and job creation

The proposed PPS policy changes support the implementation of **More Homes, More Choice: Ontario's Housing Supply Action Plan**. The Action Plan includes a series of distinct but coordinated initiatives to address housing supply, including a review of the Provincial Policy Statement. The proposed PPS changes work together with other recent changes to the land use planning system – including to the Planning Act through **Bill 108, More Homes, More Choice Act, 2019** (once proclaimed) and **A Place to Grow: Growth Plan for the Greater Golden Horseshoe**.

Background

The Ottawa Valley Tourist Association (OVTA) is the destination marketing organization (DMO) for the County of Renfrew and the City of Pembroke, operating as a not-for-profit corporation with a sixty-two year history of successful tourism marketing and product development in the Ottawa Valley. Governed by a volunteer board of directors elected by its' membership, the OVTA represents the voice of the local tourism industry and more than 225 tourism businesses, comprised of accommodations, attractions, outfitters, restaurants and retail establishments, artists and galleries, as well as trail user organizations and clubs.

In December 2017, the Province of Ontario enacted legislation granting municipalities the authority to implement a tax on short-term transient accommodations, referred to as the **Municipal Accommodation Tax (MAT)**.

To assist the local tourism industry and municipalities in fully understanding the new legislation, the OVTA Board of Directors recommended that a presentation of the origins of the MAT legislation and the extent of implementation in municipalities across Ontario, be prepared and presented. The objective of this effort was to ensure the tourism industry was fully informed of the legislation and to gather feedback from the accommodation sector.

Research and Consultation

County tourism and economic development staff conducted a comprehensive survey to identify the origins and structure of the legislation, number of accommodations located in Renfrew County and the City of Pembroke, and calculate the revenue potential. An analysis of the MAT situation across Ontario was prepared to show where Destination Marketing Programs (DMP) and Destination Marketing Fees (DMF) already existed, where MAT has been implemented as a replacement for a DMF, and what MAT rates are being applied.

The asset inventory data included both roofed and non-roofed accommodations represented by hotels, motels, bed and breakfasts, inns, lodges, resorts, cottage/cabin rentals, campsites, RV sites and Airbnb listings. With the data assembled, the revenue potential for each individual municipality was calculated.

Four industry stakeholder sessions were conducted across Renfrew County in an effort to inform the accommodation industry about the tax, potential revenue stream to municipalities and impacts to the Ottawa Valley tourism sector. The objective of this effort was to ensure the tourism industry was fully informed of the legislation, to gather feedback from the accommodation sector and then to share the report and industry feedback with county and municipal councils. This report was presented to County Council on March 27, 2019 and since that date to five municipal councils.

Challenges and Opportunities

Over this same period, the Province of Ontario has reduced its' overall tourism investment with funding cuts to the Celebrate Ontario program, Regional Tourism Model and the annual operating budgets of the Regional Tourism Organizations (RTOs). The latter has resulted in a budget reduction of \$184,000 for RTO 11, Ontario's Highlands Tourism Organization (OHTO), which represents the County of Renfrew and the City of Pembroke. This will have a direct negative effect on the tourism marketing and product development funding opportunities available to the tourism industry in the Ottawa Valley.

Across all public service sectors, the Province of Ontario has reduced financial support indicating more funding reductions and on-going requirements for operating efficiencies will need to be achieved by all municipalities and provincially mandated services.

The Municipal Accommodation Tax (MAT) is a legislated revenue generation tool available to municipalities as a means to compensate for provincial funding restraint. Implementing the MAT provides an opportunity to invest in locally identified strategic areas of community and economic growth.

Position

In this climate of provincial funding reductions, and recognizing the critical importance of the tourism industry to the economies of Renfrew County and the City of Pembroke, the OVTA Board of Directors fully supports and recommends the implementation of a Municipal Accommodation Tax (MAT) by all municipalities in the County of Renfrew and by the City of Pembroke.

In order to maintain pricing equilibrium and competitiveness amongst municipalities, the OVTA Board of Directors further recommends all 17 municipalities in the County of Renfrew and the City of Pembroke coordinate a region-wide Ottawa Valley Municipal Accommodation Tax program under the following guiding principles:

- common rate of 4%
- MAT applied to **roofed** accommodations only, including Airbnb
- 50/50 revenue sharing with an eligible tourism entity

The OVTA Board of Directors further recommends that the Ottawa Valley Tourist Association (OVTA) be the designated eligible tourism entity to receive 50% of the MAT revenues (less the reasonable costs for collecting and administering the tax) and to collaborate with municipalities for tourism marketing, promotion and product development.

Dear Council Members,

My name is Monica Nikopoulos, spokesperson and founder of Limerick Area Conservation Coalition. LACC was formed because mining exploration projects were accidentally discovered in Limerick Township in Hastings County last July 2018. Our community was completely unaware about this nickel-cobalt-copper exploration Project and the devastation to our environment that the planned drilling would've created last fall in prime cottage country.

Thankfully, with a combination of First Nation intervention, community outcry and Limerick's Resolution, the investor terminated all contracts with the Project.

Unfortunately, there's several more exploration projects in Hastings as well as the Counties of Renfrew, Peterborough and Haliburton. Council members may not have full knowledge of the widespread economic and environmental impacts regarding these explorations and how they can affect your revenues. Current government changes are aimed at making these explorations easier and the outdated Mining Act doesn't give townships control over your regions, therefore explorations could be happening in your township without your knowledge.

In March 2019, Limerick Township took the lead in Hastings County to pass a Resolution deeming explorations projects as incompatible with the social and environmental conditions of the area as well as the social and economic goals of the township and the aspirations of the residents. Since then, LACC has given delegations to most of the townships in Hastings regarding this issue.

I've created an informational youtube video about mining explorations in south eastern ON and the effects it could have on your township. I'm hoping you'll watch this and read the attached pdf's which provide more information, lincs and provide answers to any questions you might have. <https://youtu.be/ubtY084CS9Y>

Just in case you're not already aware, the Government of Ontario has set up the Environmental Registry to let the public know about environmental matters. Through this site, you are able to comment and take part in provincial government decision-making regarding Acts, regulations, policies and instruments (e.g. permits, approvals and orders).

By signing up for the Registry and monitoring the weekly updates, townships would receive proposals and decisions about any mining exploration Plans or Permits that may pertain to your township that could otherwise go unnoticed, or doesn't qualify under the Mining Act for notification. <https://ero.ontario.ca/>
