UOV OPP RESPOND TO 40 MOTOR VEHICLE COLLISIONS IN ONE WEEK Slow down, stay alert, stay in control

(PEMBROKE, ON) – Members of the Upper Ottawa Valley (UOV) Detachment of the Ontario Provincial Police (OPP) responded to 40 motor vehicle collisions during a one-week period from November 28 to December 4, 2024. Several collisions occurred during the recent forecasted adverse weather conditions. Motorists are reminded to remove any accumulated snow on their vehicle prior to starting out and to adjust their driving behaviours when winter driving conditions arise.

Drivers are reminded of the Collision Reporting Centre (CRC) located at the UOV Detachment (Pembroke Site) at 77 International Drive in the City of Pembroke. Motorists involved in a property damage collision are now able to report their collision at the CRC within 48 hours of the occurrence. The CRC is open from 8:00 a.m. to 4:00 p.m. Monday to Friday each week.

The Highway Traffic Act requires that all collisions where people are injured or property damage is valued at more than \$2,000.00 to vehicles or property, or damage to any highway property to be reported to police forthwith. Reporting to the CRC will meet this requirement.

Property damage crashes consume a large amount of police resources and time as well as put all involved occupants at risk of being involved in a secondary collision and greater risk of injury. The UOV OPP continues to offer the same excellent service in responding to collisions that require an officer to attend however, many collisions on our highways and roadways are minor in nature and drivers are able to clear their vehicles quickly and safely off the highway without police assistance. An officer who attends a collision may direct those involved persons to attend the CRC if all the criteria are met.

Dear Mayor Grills:

Our government is proud to have a strong working relationship with both our municipal partners and the police services that keep our communities safe. The collective agreement that was reached between the province and the Ontario Provincial Police Association (OPPA) earlier this year reflects this strong relationship and will support our brave women and men in uniform across Ontario.

At the same time, we understand the impact these changes are having on the budgets of municipalities that are served by the OPP, including your own, which is why we are stepping up with additional provincial support. With that in mind, I am pleased to share with you the following proposed billing changes:

- A 3.75 per cent reduction of the total 2023 reconciled costs to all communities to approximate the full (100 per cent) impact of the Ontario Provincial Police Association (OPPA) salary increases, excluding the 1 per cent increase that was built into the 2023 estimates; and
- A 44 per cent reduction on overtime 2023 reconciled costs to all communities;
- A 10 per cent reduction of 2025 invoice amounts to all communities to approximate the full (100 per cent) impact of the OPPA salary increases excluding the 1 per cent increase that was already built into the 2023 estimate.

These changes would provide over \$77 million in relief to OPP-policed municipalities.

The total billing statement that was initially provided to you for 2025, inclusive of the increases resulting from the new collective agreement, was \$101,745. Today's proposed billing changes will provide an estimated \$14,880 in financial relief for your municipality, bringing the new total for OPP services being billed to your municipality in 2025 to \$86,865.

In addition to these changes, the Government of Ontario is continuing its annual \$125 million Court Security & Prisoner Transportation Transfer Payment Program for the 2025 calendar year. The province will also be examining options for reviewing the OPP billing model to ensure that it meets the needs of communities across the province.

Subject: Canada Post Labour Disruption

As you may know, the Canadian Union of Postal Workers (CUPW) began a national strike on November 15, 2024.

ServiceOntario is working to minimize the impact on government services during the Canada Post labour disruption and to continue to provide registration and certificate services to Ontarians. We appreciate that the postal service disruption is inconvenient, and we are doing everything we can to ensure critical services and benefits continue to be delivered in a timely manner.

As a temporary measure, municipalities are kindly requested to forward vital event registration documents (death, stillbirth and marriage) to our office via courier weekly, as required. Alternatively, municipalities are to hold registration documents until the end of the labour disruption.

Please remember that you are responsible for the proper handling of vital event registration documentation. A significant part of this responsibility is safeguarding the original documents and the information they contain. In the event we receive an urgent request to expedite a death, stillbirth or marriage registration (if the municipal clerk/delegate has performed the marriage) we will contact you and request that the registration documents be couriered to our office.

Ontarians should be directed to visit <u>http://www.ontario.ca\mail</u> for information on critical government services and programs during the strike. All ServiceOntario centres, government call centres and online services are open for business as usual.

Foreign Divorce Authorizations:



Please instruct couples planning to marry to courier their request and documentation to the Office of the Registrar General, Attention: Foreign Divorce Authorization. Completed authorizations will be sent via courier to the couple.

Expediting a Marriage Registration:

In the event a recently married couple requires their marriage registration to be expedited, they should be encouraged to speak with the person performing their marriage to make arrangements to have their marriage licence couriered to the Office of the Registrar General.

Dear Head of Council:

Through the *More Homes Built Faster Act, 2022*, changes were made to the *Planning Act* to accelerate implementation of the province's additional residential unit (ARU) framework. These changes allowed "as-of-right" (without the need to apply for a rezoning) the use of up to 3 units per lot in many existing residential areas (i.e., up to 3 units allowed in the primary building, or up to 2 units allowed in the primary building and 1 unit allowed in an ancillary building such as a garage).

To support implementation of ARUs, the *Cutting Red Tape to Build More Homes Act, 2024*, made further changes to the *Planning Act* to provide me, as the Minister of Municipal Affairs and Housing, with broader regulation-making authority to remove municipal zoning by-law barriers that may be limiting the development of ARUs.

Following consultation on the Environmental Registry of Ontario, our government has taken further action to tackle the housing supply crisis and reach our goal of building more homes by amending <u>Ontario Regulation 299/19 – Additional Residential Units</u> to remove certain municipal zoning by-law barriers. These changes took effect upon filing.

These changes will help to facilitate the creation of ARUs, such as basement suites and garden suites, by eliminating barriers including maximum lot coverage, angular planes, floor space index (FSI), minimum separation distances and minimum lot sizes on parcels of urban residential land subject to the ARU framework in the *Planning Act*. More information on these changes can be found through <u>Environmental Registry of Ontario posting 019-9210</u>.

It is my expectation that municipalities will respect these regulatory changes and the intent behind them. I will not hesitate to use my available powers to ensure these changes to the *Planning Act* are allowed to support our goal of building more homes.

Good Morning,

I am pleased to share an important milestone related to the modernization of wildland fire management in Ontario. On Monday, November 25th, the Hon. Graydon Smith, Minister of Natural Resources, introduced Bill 228, *Resource Management and Safety Act, 2024*. Included in the bill is a proposal to make amendments to the *Forest Fires Prevention Act* (FFPA).

The FFPA provides the legal framework for wildland fire management in Ontario by setting out prevention, response and compliance measures. The FFPA has not had significant changes since 1999. The bill introduced today proposes a suite of legislative amendments to the FFPA that are intended to address the current and future threat of wildland fires, and to support the modernization of wildland fire management in the province.

These changes would help strengthen collective responsibility for wildland fire management, improve awareness of wildland fire risk, expand prevention and mitigation, enhance preparedness and response, and strengthen rules and consequences for non-compliance with wildland fire laws.

Specifically, the proposed amendments would change the name of the FFPA to the *Wildland Fire Management Act* and introduce a new purpose statement "to provide guidance and direction for wildland fire management so as to protect public safety, minimize adverse environmental, economic, health and social impacts of wildland fires, and contribute to a resilient province."

Proposed amendments include the following:

- 1. Section 19 of the Act would be amended to clarify authority for the Minister to enter into agreements on all aspects of wildland fire management.
- 2. A new section 14 would be added to the Act to require municipalities and certain industries in the fire region to have a wildland fire management plan that meets prescribed standards as set out in regulation. This could be updating an existing plan or preparing a new plan.
- 3. Section 23 of the Act would be amended to clarify the Minister's order power to prohibit activities in areas that have been declared a wildland fire emergency area, and provide the Minister with the authority to issue a permit allowing certain activities in certain circumstances.
- 4. A new section 35.1 would be added to the Act to create a new power for the Minister to issue a remediation order and provide for opportunity for review of the order.
- 5. Section 7 of the Act would be amended to enable the Minister to set out standard rates, terms and conditions (and their application/use) when privately owned equipment and operators are used to respond to wildland fires and wildland fire emergency events.

- 6. A new section 35.2 would be added to the Act to enable administrative monetary penalties to address non-compliance with the FFPA and provide for an opportunity for review of the penalty.
- 7. Section 21.1 of the Act would be amended to enable the Minister to exercise discretion in determining whether the costs of suppressing or extinguishing a human-caused fire and associated damages will be recovered.
- 8. Amendments throughout the Act to inspection, investigation and enforcement sections including amending section 4 of the Act to create four categories of officer; replacing section 5 of the Act with new sections 5 to 5.9 to add more comprehensive inspection, investigation, and enforcement powers; setting out the limitation period for offences in subsection 35(9); and, allowing courts to issue a wider range of orders to ensure compliance upon conviction in subsection 35(1.1).
- 9. Amendments to administrative components of the Act to make administrative amendments, including changing the name of the Act, adding a purpose section and revoking and updating certain definitions.

I want to take this opportunity to thank those of you who participated throughout the ministry's recent consultation and engagement efforts related to the modernization of wildland fire management in Ontario. The feedback provided in response to our <u>discussion paper</u> and at various in-person and virtual engagement sessions assisted in informing the development of these proposals, and I appreciate the time and effort from all those who were able to submit comments or meet with us.

The introduction of this bill is a significant achievement as we continue to modernize wildland fire management in Ontario. If you have any questions, please email the team at <u>Wildlandfire@ontario.ca</u>.

We look forward to continuing to work with you to improve wildland fire management in Ontario to help keep people and communities safe from wildland fire risk.

J'ai le plaisir de partager une étape importante liée à la modernisation de la gestion des feux de végétation en Ontario. Le lundi 25 novembre, l'hon. Graydon Smith, ministre des Richesses naturelles, a déposé le projet de loi 228, la *Loi de 2024 sur la gestion et la sécurité des ressources*. Le projet de loi contient une proposition visant à apporter des modifications à la *Loi sur la prévention des incendies de forêt* (LPIF).

La LPIF fournit le cadre juridique de la gestion des feux de végétation en Ontario en établissant des mesures de prévention, d'intervention et de conformité. La LPIF n'a pas subi de changements importants depuis 1999.Le projet de loi présenté aujourd'hui propose une série de modifications législatives à la LPIF qui visent à contrer la menace actuelle et future des feux de végétation et à appuyer la modernisation de la gestion des feux de végétation dans la province.

Ces changements contribueraient à renforcer la responsabilité collective à l'égard de la gestion des feux de végétation, à accroître la sensibilisation au risque de feux de végétation, à élargir les mesures de prévention et d'atténuation, à améliorer la préparation et l'intervention, et à renforcer les règles et les conséquences en cas de non-conformité aux lois sur les feux de végétation.

Plus précisément, les modifications proposées changeraient le nom de la LPIF à la *Loi sur la gestion des feux de végétation* et introduiraient un nouvel énoncé d'objectif « afin de fournir des orientations et des directives pour la gestion des feux de végétation de façon à protéger la sécurité publique, à limiter les répercussions environnementales, économiques, sanitaires et sociales négatives des feux de végétation, et à contribuer à la résilience de la province ».

Voici les modifications proposées :

- 2. L'article 19 de la Loi serait modifié pour clarifier le pouvoir du ministre de conclure des ententes sur tous les aspects de la gestion des feux de végétation.
- 3. Un nouvel article 14 serait ajouté à la Loi pour exiger des municipalités et de certaines industries dans la région touchée par les incendies de se doter d'un plan de gestion des feux de végétation qui respecte les normes prescrites, conformément aux règlements. Il peut s'agir de mettre à jour un plan existant ou de préparer un nouveau plan.
- 4. L'article 23 de la Loi serait modifié afin de clarifier le pouvoir du ministre d'interdire des activités dans des zones d'urgence pour les feux de végétation et de conférer au ministre le pouvoir de délivrer un permis autorisant certaines activités dans des circonstances particulières.
- 5. Un nouvel article 35.1 serait ajouté à la Loi afin de conférer au ministre le pouvoir d'émettre une ordonnance de remédiation et de prévoir la possibilité de la réviser.
- 6. L'article 7 de la Loi serait modifié pour permettre au ministre d'établir des taux, des modalités et des conditions normalisés (ainsi que leur application et leur utilisation) lorsque de l'équipement et des exploitants privés sont utilisés pour intervenir en cas de feux de végétation et de situations d'urgence liées à des feux de végétation.
- 9. Un nouvel article 35.2 serait ajouté à la Loi afin de permettre l'application de sanctions administratives pécuniaires en cas de non-respect de la LPIF et de prévoir la possibilité d'une révision de la sanction.

- 10. L'article 21.1 de la Loi serait modifié afin de permettre au ministre d'exercer son pouvoir discrétionnaire pour déterminer si les coûts d'extinction d'un incendie d'origine humaine et les dommages connexes seront recouvrés.
- 11. Des modifications seraient apportées à la Loi dans les articles relatifs à l'inspection, aux enquêtes et à l'exécution, notamment : une modification de l'article 4 de la Loi afin de créer quatre catégories d'agents; le remplacement de l'article 5 de la Loi par les nouveaux articles 5 à 5.9 afin d'ajouter des pouvoirs d'inspection, d'enquête et d'exécution plus étendus; la fixation du délai de prescription pour les infractions, au paragraphe 35(9); la possibilité pour les tribunaux d'émettre un plus large éventail d'ordonnances afin d'assurer le respect de la loi en cas de condamnation, au paragraphe 35(1.1).
- 10. Des modifications seraient apportées aux éléments administratifs de la Loi afin d'apporter des modifications administratives, notamment le changement du nom de la Loi, l'ajout d'un article sur l'objectif ainsi que la révocation et la mise à jour de certaines définitions.

Dear Minister Sarkaria:

I am following up on our meeting this past spring at which we presented some proposals for traffic management on Highway 17 in Renfrew County. I will note the Council of the Corporation of the County of Renfrew, the City of Pembroke and our community are deeply concerned about the ongoing funding issues that seemingly exist and negatively impact on the timely upgrading of Highway 17 in the County of Renfrew.

Our community was shocked and disappointed to see no mention of Highway 17 twinning in the 2024 Economic Statement - The 2024 Ontario Economic Outlook and Fiscal Review: Building Ontario for You document as tabled in the legislature by the Honorable Peter Bethlenfalvy on October 30th. We are appreciative of the overpass constructed in McNab Braeside at the Calabogie Road intersection. It has been noted by many that the in-ground infrastructure installed at the time could greatly facilitate future twinning of this provincial highway beyond the footprint of the overpass.

The Ontario Highways Program features 635 expansion and rehabilitation projects that are either underway or planned over the next four years and Highway 17 twinning in our community is not one of them. In 2024–25 alone, the Province of Ontario has reported investing almost \$3.9 billion towards projects that will expand and repair provincial highways and bridges, and again no further investment in twinning Highway 17 in our community.

The County of Renfrew and the City of Pembroke are committed to improving the health and safety of their residents and would like to meet with you in Toronto at your convenience. We would like to review some ideas about Highway 17 and extending 417. Our residents are quite correctly asking why money is being set aside for such projects as the Bradford By Pass, Highway 413, the estimated \$1.2B uploading of the Don Valley Parkway and the Gardner. I travel in the Toronto region a lot and can offer comment to address the need, but I fail to provide compelling rationale when the conversation turns to equity and which community has been waiting (patiently) the longest.

We would also like to discuss with you the continued partnership with your Ministry of keeping cyclists safe on Highway 17 by removing them to an alternate route. This has been a very successful partnership, which we would like to continue with you and your Ministry. Our community would also like to continue discussing our traffic solutions for the Meath Hill to Deep River section of Highway 17. The suggested proactive series of roundabouts and 2+1 builds can contribute to smoother traffic flow by eliminating traffic signal lights as well as provide a better and safer travelling experience. County officials would also like to discuss the progress of what we feel is the next logical expansion of the 17 corridor, Scheel Drive through to Millar Road. It is relatively flat, has no wetlands, moves traffic quicker to the Calabogie exit, and seemingly would demonstrate little difficulty in constructing and at the same time reassure many with some progress.

Statement from County of Renfrew on MPP Yakabuski retirement announcement

Following the announcement from Renfrew-Nipissing-Pembroke MPP John Yakabuski that he will not seek re-election when Ontarian next go to the polls, the County of Renfrew is expressing its gratitude for MPP Yakabuski's support during his two decades serving at the Provincial Legislature.

This past June, MPP Yakabuski was honoured by Renfrew County Warden Peter Emon and County Council for his more than 20 years of dedicated service representing the riding. He was joined by members of his family, current and former staff members, and former wardens who recognized his numerous achievements and contributions over the years.

During his remarks, Warden Emon highlighted some of the larger projects MPP Yakabuski has advocated for, including permanent funding for the Renfrew County Virtual Triage and Assessment Centre (RC VTAC), funding for the Community Paramedicine for Long-Term Care program pilot, updates to our Official Plan, the Renfrew County 2023 Ontario Winter Games and the expansion of Highway 17 through Renfrew County.

MPP Yakabuski was also instrumental in two successful Renfrew County Days at Queen's Park; the first of which allowed the County to highlight local businesses and industries and the second which allowed senior staff to advocate for funding for County programs and initiatives, including Mesa, increased housing, mental health and addictions supports and infrastructure improvements. Hello,

Over the past two years, the Ministry of Natural Resources has been taking a measured and phased approach to enabling and regulating geologic carbon storage in Ontario. Carbon storage is new to the province, and developing a comprehensive framework to regulate this activity would help ensure that it is done responsibly, with measures in place to safeguard people and the environment.

Geologic carbon storage (further referred to as carbon storage) involves injecting captured carbon dioxide (CO2) into deep geological formations for permanent storage. This technology could provide industries in Ontario with a critical tool for managing their emissions and contributing to the achievement of Ontario's emissions reduction targets.

Today, we are writing to notify you that 1) a decision has been made to proceed with the development of a framework for enabling commercial-scale geologic carbon storage (Environmental Registry of Ontario posting # 019-8767), and 2) that a new *Geologic Carbon Storage Act* is being proposed (Environmental Registry of Ontario posting # 019-9299).

These developments represent significant steps towards Phase 3 of Ontario's <u>approach</u> to enabling and regulating geologic carbon storage. Ontario aims to have a framework in place by summer 2025. Initially, the ministry anticipates that commercial-scale projects would be proposed in Southwestern Ontario, where the geology is expected to be the most suitable.

 In the summer of this year, we shared information about the development of a legislative and regulatory framework for commercial-scale geologic carbon storage. This information included a discussion paper that provided an overview of how various components of the framework could function. Based on feedback received, a decision was made to move forward with the development of the framework. More details on the decision, the feedback received, and the original discussion paper can be viewed in the decision notice on the Environmental Registry of Ontario: <u>https://ero.ontario.ca/notice/019-8767</u>.

2) Based on comments received in response to the discussion paper, as well as feedback received in previous phases of framework development, a *Geologic Carbon Storage Act* (the "Act") is being proposed. The proposed Act would enable the regulation of research and evaluation activities, and carbon storage activities associated with the permanent storage of carbon dioxide in underground geologic formations in Ontario.

We encourage you to review, and submit feedback on, the legislative proposal on the Environmental Registry of Ontario posting # 019-9299.

Ontario is committed to reducing regulatory burdens across industry sectors to accelerate the development of housing, highways and other critical infrastructure while continuing to protect the environment.

I am reaching out to share that the Ministry of the Environment, Conservation and Parks (MECP) is proposing to amend O. Reg. 153/04: Records of Site Condition ("RSC Regulation") and the Environmental Protection Act (EPA). This is to support building more homes faster by reducing the need for a record of site condition where it is not supporting brownfields redevelopment. These proposed amendments would apply to low-risk sites and would continue to ensure that human health and the environment are protected.

We are now proposing the following amendments and seeking comment through an Environmental Registry of Ontario (ERO) and Regulatory Registry posting:

- Regulatory amendments to the RSC Regulation that would prohibit a record of site condition
 from being submitted for filing in the Record of Site Condition Registry, if it is not otherwise
 required by the EPA or RSC Regulation and the RSC was prepared solely on the basis of a
 phase one environmental site assessment. In this circumstance, no potentially contaminating
 activities or areas of potential environmental concern have been identified for that property.
 These RSCs are not necessary to demonstrate that contaminants have been addressed to
 support brownfields redevelopment. An exception to this prohibition is proposed that would
 allow a property owner to submit an RSC for filing based on a phase one ESA if it is not as a
 result of a requirement of another person.
- To further support housing, regulatory amendments are also proposed to expand an existing exemption from the requirement to file an RSC when converting existing commercial or community use buildings (e.g., office buildings) to mixed use containing residential or institutional uses. A restriction on building height of six storeys for this exemption to apply would be removed, while other criteria remain in place.

The posting also describes legislative amendments to the EPA that would, if passed, provide regulation-making authority to prohibit RSCs from being submitted for filing in specified circumstances.

CC23.1 ACTION Amended Ward: Al

Respecting Local Democracy and Cities

City Council Decision

City Council on November 13 and 14, 2024, adopted the following:

1. City Council express its opposition to the proposed amendments to Part XII of the Highway Traffic Act contained in Bill 212, and any related proposed regulations, both of which contradict the stated purpose of the City of Toronto Act, 2006, to allow the City to determine what is in the public interest of the city.

2. City Council request the Province to work collaboratively with cities to address congestion and road safety, and accordingly withdraw the proposed amendments to Part XII of the Highway Traffic Act contained in Bill 212.

3. City Council direct the City Solicitor to review Bill 212 and any accompanying regulations, once in force, and to report to City Council with a summary of the legislation and regulations and the potential for commencing litigation to challenge Bill 212 or the regulations.

4. City Council request the General Manager, Transportation Services, or designates, to appear before the Ontario Legislature's Standing Committee on Heritage, Infrastructure, and Cultural Policy as part of public hearings regarding Bill 212 to give testimony in accordance with the position outlined in this item.

5. City Council request the City Manager to submit written comments to Ontario's Regulatory Registry and Environment Registry of Ontario that reflect the City's positions outlined in this item, including the City's opposition to any requirement of the City to provide support in the removal of City Infrastructure approved by its democratically elected City Council.

6. City Council adopt the position that no costs associated with the amendments to Part XII of the Highway Traffic Act should be incurred or paid by the City of Toronto, including staff time, planning, design, construction, and traffic management as a result of the congestion created by the removal.

7. City Council forward this item to the Premier of Ontario, the Minister of Transportation, the Minister of Municipal Affairs and Housing, the Leader of the Official Opposition, all Ontario Members of Provincial Parliament, the Association of Municipalities of Ontario, the Ontario Big City Mayors, and all Ontario municipalities and include City Council's commitment to the right of municipalities to govern their own affairs and represent the interests of their residents and electors.

8. City Council request the Ministry of Transportation to permit the publication of the results of the Transportation Tomorrow Survey 2022 as soon as possible to facilitate the use of the study in informing collaborative consultations with cities regarding options for addressing congestion and road safety.

9. City Council direct the City Manager to report back on the feasibility of placing signs on City roads where there are traffic delays resulting from the Provincial mandate to remove bike lanes from Toronto roads and that these signs would read "This road congestion and traffic delay is the result of Premier Ford's Bill 212".

10. City Council direct that Confidential Attachment 1 to the supplementary report (November 13, 2024) from the City Manager remain confidential in its entirety, as it contains information explicitly supplied in confidence to the City of Toronto as a partner municipality in the Transportation Tomorrow Survey 2022, conducted by a consultant retained by the Ministry of Transportation of Ontario as part of a cooperative effort by local and provincial government agencies to collect information about urban travel in southern Ontario, until such time as the Transportation Tomorrow Survey 2022 is authorized to be published by the Ministry of Transportation of Ontario.

Confidential Attachment 1 to the supplementary report (November 13, 2024) from the City Manager remains confidential in its entirety in accordance with the provisions of the City of Toronto Act, 2006, as it contains information explicitly supplied in confidence to the City of Toronto as a partner municipality in the Transportation Tomorrow Survey 2022, conducted by a consultant retained by the Ministry of Transportation of Ontario as part of a cooperative effort by local and provincial government agencies to collect information about urban travel in southern Ontario, until such time as the Transportation Tomorrow Survey 2022 is authorized to be published by the Ministry of Transportation of Ontario.

Summary

The recent provincial Bill 212 seeks to overturn the decisions and work of our locally elected Toronto City Council. If passed, the Bill means one government would, at tremendous cost to the taxpayer and without collaboration, undo another government's work.

As Mayor, it is my responsibility to stand up for the decision-making authority of City Council and the expertise of our professional public service which supports that decision-making. As such, I am working with City Staff to review the City's options and will provide recommendations on this item prior to the City Council meeting on November 13, 2024.

Re: The Future for Billy Bishop Airport Requires Urgent Action and a Modern Governing Agreement

Dear Minister Anand and Mayor Chow,

I am writing to you to express my support for the sustained operation and development of Billy Bishop Toronto City Airport. As the President of the Northwestern Ontario Municipal Association, I am extremely concerned to learn that the Tripartite Agreement that governs operations at the Airport expires in 2033 – less than 9 years from now.

Billy Bishop Airport provides a critical service and point of connection for the North. Many of my community members rely on Billy Bishop airport to visit family, connect through to other destinations for work, travel and tourism or to access critical medical services, the convenience and ease of Billy Bishop Airport cannot be matched. It has been reported widely that Northern Ontario communities have experience drastic reductions in air service coming out of the COVID pandemic. Reliable air connectivity available through Billy Bishop Airport is an important economic and social lifeline for my community.

We were pleased to see the Federal Government's investment in a US Customs and Border Patrol preclearance facility, which is expected to open in 2025. This is welcomed news for communities in Northwestern Ontario as it will enable more and better connections through Billy Bishop Airport and amplify the airport's already strong economic contribution. We viewed this investment in the airports long term future as recognition of the very important role the airport has come to play for the communities it connects including Northwestern Ontario – very much at odds with an agreement that expires in a matter of years.

To that end, we would implore you, as signatories to the Tripartite Agreement, to commence a process to modernize the Tripartite Agreement and secure the long-term future of Canada's 9th-busiest airport and 3rd-busiest in Ontario. My community members rely on this service, and we

want to see even more connections and expanded services to the North. As elected leaders, we have a responsibility to think past our own front doors, reflect the needs of all of our constituents and those beyond our communities who are impacted by our decisions. Certainty about the airport's long-term future should not be something we as leaders should need to think long about. The time is now for the parties of the agreement to move forward with urgency to ensure this vital piece of transportation infrastructure and the important connections it facilitates are sustained.

Hamilton City Council, at its meeting held on Wednesday, November 13, 2024, passed the following resolution:

7.1 Opposing the Proposed Provincial Initiative that Seeks to Restrict or Limit the Autonomy of Municipalities in Implementing Road Safety Measures

(Kroetsch/Cassar)

WHEREAS, the safety of all road users, including cyclists, is a paramount concern and a fundamental responsibility of both provincial and municipal governments;

WHEREAS, crashes involving motor vehicles pose significant risks to cyclists, pedestrians, and other vulnerable road users, leading to serious injuries and fatalities;

WHEREAS, the implementation of safe road infrastructures, such as bike lanes, is a proven measure to enhance the safety and accessibility of roadways for cyclists, promoting healthier and sustainable transportation options;

WHEREAS, the Office of the Chief Coroner of Ontario ("OCC") conducted the Cycling Death review, which was the most comprehensive death review into the causes of cycling deaths in Ontario;

WHEREAS, the OCC made its primary recommendation to the province the adoption of "Complete Streets" which emphasize the need for comprehensive planning and design of roadway infrastructure to safely accommodate all users, including through the installation of more cycling networks including bike lanes;

WHEREAS, municipal governments have the local knowledge and contextual understanding necessary to effectively address specific community transportation needs, including the development and maintenance of safe cycling infrastructure within their cities;

WHEREAS, any provincial initiative that seeks to prevent or preclude municipalities from implementing necessary road safety measures, such as bike lanes, undermines local governance and the ability of municipalities to protect the well-being of their residents and ensure compliance with their obligations that roadways are reasonably safe for all users; and

WHEREAS, this resolution expresses the City of Hamilton's commitment to supporting municipal autonomy in enhancing road safety and emphasizes the importance of integrating protective measures for cyclists through locally tailored infrastructure solutions.

THEREFORE, BE IT RESOLVED:

- (a) That Hamilton City Council formally oppose any proposed provincial initiative that seeks to restrict or limit the autonomy of municipalities in implementing road safety measures, including the establishment and or removal of bike lanes or bike infrastructure;
- (b) That Hamilton City Council supports the empowerment of municipal road authorities to independently assess and recommend the best methods to ensure the safety of all road users within their jurisdictions and responsibilities; and
- (c) That a copy of this resolution be forwarded to the Honourable Doug Ford, Premier of Ontario; the Honourable Prabmeet Singh Sarkaria, the Minister of Transportation; the Honourable Paul Calandra, the Minister of Municipal Affairs and Housing; the area MPPs and MPs, the Association of Municipalities of Ontario and all Ontario Municipalities.

RE: 10.1 ERO Posting 019-9196 Enabling greater beneficial reuse excess soil

Please be advised that Township of Puslinch Council, at its meeting held on November 20th, 2024 considered the aforementioned topic and subsequent to discussion, the following was resolved:

Resolution No. 2024-415: Moved by Councillor Hurst and Seconded by Councillor Sepulis

That Council receive the Mayors and Council member updates for information. Whereas the Ministry of the Environment, Conservation and Parks is currently consulting on proposed amendments to the Excess Soil Regulation, with potentially significant implications for local municipalities; and

Whereas these proposed changes, including landfilling restrictions and exemptions for waste environmental compliance approvals, pose substantial risks to environmental



integrity, groundwater protection, local enforcement efforts, and land use planning; and

Whereas the proposed amendments may undermine local municipalities' ability to effectively manage excess soil, potentially leading to adverse environmental impacts, such as soil and/or groundwater contamination and disruption of local ecosystems; and

Whereas the relaxation of regulatory requirements for soil management could further hinder the enforcement capabilities of municipal authorities, making it more challenging to monitor and address compliance issues, thus jeopardizing public health and safety; and

Whereas the proposed regulations do not provide sufficient clarity regarding whether the intent of the proposed regulations are to permit ARA licensed sites to be used as reuse sites for excess soil; and

Whereas the proposed flexibility in soil reuse standards could conflict with established land use planning frameworks, potentially resulting in incompatible land uses and further strain on local infrastructure; and

Whereas the introduction of regional mapping for areas with naturally occurring exceedances presents significant financial challenges for municipalities, as the costs associated with implementing such mapping projects may not be feasible given limited budgets and resources; and

Whereas relaxing excess soil regulations and implementing regional mapping could negatively impact agricultural lands by allowing excess soil to be disposed of in ways that diminish the quality and usability of these valuable lands for future agricultural purposes, highlighting the need to prioritize the protection of agricultural lands equally with infrastructure projects and housing developments;

Therefore, be it resolved that the Council of Township of Puslinch formally objects to the proposed amendments to the Excess Soil Regulation, citing concerns regarding the detrimental effects on local municipalities, the environment, soil and groundwater quality protection, and effective land use planning; and



That the Council of Township of Puslinch directs staff to forward this resolution to the Ministry of the Environment, Conservation and Parks, outlining these concerns and advocating for a more balanced approach that prioritizes environmental protection, local governance, and the protection of resident's health and safety; and further,

That this resolution be shared with all Ontario Municipalities, the Premier of Ontario; County Planning staff, MPP Arnott; MPP Rae; the Wellington Federation of Agriculture; and OMAFRA requesting support for the protection of agricultural lands and sustainable excess soil management practices in Ontario.
