RE: Town of Lincoln Council Resolution – Urgent Need for Increased Funding to Libraries and Museums in Ontario

Please be advised that the Council of the Corporation of the Town of Lincoln at its Council Meeting held on February 26, 2024, passed the following motion regarding an Urgent Need for Increased Funding to Libraries and Museums in Ontario:

Resolution No: RC-2024-23

Moved by Mayor Easton; Seconded by Councillor Mike Mikolic

WHEREAS the provincial funding for public libraries is currently based on population levels from 25 years ago, which fails to reflect the substantial growth and changing needs of our communities. The Town of Lincoln Council wishes to draw your attention to the "Overdue" report of 2023 from the Canadian Urban Council, which emphasizes the pivotal role libraries play in various aspects of community life, including knowledge distribution, culture, health, reconciliation, belonging, and our democracy; and

WHEREAS libraries, situated at the heart of our communities, serve as multifaceted institutions catering to diverse needs. They provide essential services such as access to culture and information, refuge for those experiencing domestic violence, election information centers, job search facilities, health clinics, language learning centers for newcomers, and spaces for educational and community events. Despite their vital role, public libraries in Ontario have not seen an increase in provincial funding for over 25 years, leading to a decrease in the value of the province's investment by over 60%; and

WHEREAS the Town of Lincoln Council urges the Provincial Government to

consider increasing provincial funding for Ontario's public libraries to address critical shared priorities and community needs. While over 90% of library funding comes from local municipal governments, provincial operating funding is crucial for providing stability to library budgets, especially in times of inflation, technological changes, and increasing demands on libraries as community hubs; and

WHEREAS the Town of Lincoln Council would like to bring to the Provincial Government's attention the pressing need to increase the funding envelope for the Community Museum Operating Grant (CMOG). The Town of Lincoln currently receives \$25,000 annually, the maximum amount through this grant, but the funding envelope has remained stagnant for over 15 years. This limitation hampers the ability of community museums to offset increasing operational expenses, impacting their role in preserving and promoting local stories, attracting cultural tourists, supplementing school curriculum, and contributing to vibrant and vital communities; and

WHEREAS the Lincoln Museum and Cultural Centre is a community hub critical to the health and vibrancy of our community. An increase in CMOG funding will enable our museum to continue its valuable service to the community, creating a sense of place, attracting cultural tourists, and preserving local stories that define our unique identity; and

WHEREAS Cultural institutions, particularly museums, play a vital role in shaping and preserving our community's identity. They contribute to tourism, social participation, senior well-being, skill-building, and learning. As the largest government funder for most of Ontario's smaller museums, municipalities create value in their communities through the work of these institutions.

THEREFORE, BE IT RESOLVED THAT the Town of Lincoln Council urges the Provincial Government to support increasing funding to both public libraries and community museums. Recognizing these institutions as national assets and strategically investing in their potential will contribute significantly to renewing post-pandemic social cohesion, economic well-being, and community resilience; and

BE IT FURTHER RESOLVED THAT this resolution be circulated to the Province, the Minister of Tourism, Culture and Sport, Association of Municipalities of Ontario (AMO), the Niagara Region, the 12 Local Area Municipalities in Niagara and all municipalities of Ontario for endorsement.

“WHEREAS the current provincial-municipal fiscal arrangements are undermining Ontario’s economic prosperity and quality of life;

AND WHEREAS nearly a third of municipal spending in Ontario is for services in areas of provincial responsibility and expenditures are outpacing provincial contributions by nearly \$4 billion a year;

AND WHEREAS municipal revenues, such as property taxes, do not grow with the economy or inflation;

AND WHEREAS unprecedented population and housing growth will require significant investments in municipal infrastructure;

AND WHEREAS municipalities are being asked to take on complex health and social challenges – like homelessness, supporting asylum seekers and addressing the mental health and addictions crises;

AND WHEREAS inflation, rising interest rates, and provincial policy decisions are sharply constraining municipal fiscal capacity;

AND WHEREAS property taxpayers – including people on fixed incomes and small businesses – can’t afford to subsidize income re-distribution programs for those most in need;

AND WHEREAS the province can, and should, invest more in the prosperity of communities;

AND WHEREAS municipalities and the provincial government have a strong history of collaboration;

NOW THEREFORE, BE IT RESOLVED THAT the Town of Bracebridge calls on the Province of Ontario commit to undertaking, with the Association of Municipalities of Ontario, a comprehensive social and economic prosperity review to promote the stability and sustainability of municipal finances across Ontario;

At their last regular meeting on Wednesday February 21, 2024, the Council of the Corporation of the Township of Perry supported the following:

"Resolution #2024-52
Moved by: Paul Sowrey
Seconded by: Jim Cushman

Whereas under Ontario Regulation 391/21: Blue Box producers are fully accountable and financially responsible for their products and packaging once they reach their end of life and are disposed of, for 'eligible' sources only;

And Whereas 'ineligible' sources which producers are not responsible for include businesses, places of worship, daycares, campgrounds, public-facing and internal areas of municipal-owned buildings, and not-for-profit organizations, such as shelters and food banks;

And Whereas should a municipality continue to provide services to the 'ineligible' sources, the municipality will be required to oversee the collection, transportation, and processing of the recycling, assuming 100% of the costs;

Be it resolved that the Council of the Corporation of the Township of Perry hereby request that the province amend Ontario Regulation 391/21: Blue

Box so that producers are responsible for the end-of-life management of recycling products from all sources;

And further that Council hereby request the support of all Ontario Municipalities;

And further that this resolution be forwarded to the Honourable Doug Ford, Premier of Ontario, the Honourable Andrea Khanjin, Minister of the Environment, Conservation, and Parks, the Honourable Graydon Smith, MPP Parry Sound-Muskoka, and to all Ontario Municipalities.

“WHEREAS, climate change annually contributes to hundreds of billions of dollars in property and infrastructure damage worldwide, stressing local to national and international economies;

WHEREAS, climate change jeopardizes the health and risks the extinction of millions of species worldwide, stressing and weakening the health and integrity of ecosystems everywhere;

WHEREAS, climate change harms the health and security of people through intense wildfires, flooding, storms, droughts, rising sea levels, the spread of invasive insects bearing diseases, negative impacts on agriculture, and food supply interruption, thus further stressing social, economic, and political systems;

WHEREAS, there is now a large body of evidence and climate change risk scenarios which point to the imperative for steep and permanent reductions in greenhouse gas emissions, immediately and in the coming decades, in order to avoid many climate change “tipping points” which, if crossed, will render further and devastating ecological, economic, and societal losses;

AND WHEREAS, a crisis can be defined as "a dangerous situation requiring immediate action";

NOW THEREFORE BE IT RESOLVED THAT, Tay Valley Township officially declares a climate change crisis for the purposes of naming, framing, and deepening our commitment in our climate action plan to protecting our local ecosystems, local economy, and our community from climate change;

THAT, this resolution be revisited each term of Council and within the first year of the new council;

AND THAT, this resolution be provided to Prime Minister Trudeau and all federal ministers with portfolios related to climate change; to all federal Opposition party leaders; to MP Scott Reid; to Premier Ford and all Ontario ministers with portfolios related to climate change; to MPP John Jordan and all other Ontario MPPs; to all Ontario Municipalities and the local media.”

I am writing to you today to share an update on Bill 21, Fixing Long-Term Care Amendment Act (Till Death Do Us Part), 2022, and to request your support for this important legislation.

Bill 21 amends the Residents' Bill of Rights set out in section 3 of Fixing Long-Term Care Act, 2021 by adding the right of residents not to be separated from their spouse upon admission but to have accommodation made available for both spouses so they may continue to live together.

The Act was inspired by Cambridge resident Jim McLeod, who will have been separated from his wife of 65 years Joan, on September 17, 2023. Nearly 6 years later, Jim continues to champion spousal reunification. He often says that he will talk to anyone and has two giant binders full of his advocacy work on the Bill. Last week, he told me that his heart is breaking because of his separation from Joan. He has brought other seniors who are separated from their spouses into the advocacy – you cannot sit with these folks for any amount of time and not care deeply about this legislation.

I know that you value the many contributions that older adults have made to Waterloo Region, and care deeply that they can live their final years with dignity and love. **I am hoping you will consider bringing a motion forward to your Council, in support of the Till Death Do Us Part Act.** Your support will help us to keep attention on this important legislation, so that it can finally be called to the Standing Committee on Social Policy – one step closer to Royal Assent.

BACKGROUND:

On November 15, 2022, the Till Death Do Us Part Act, passed second reading in the Ontario legislature after being [introduced for the third time in September 2022](#). The bill was then referred to the Ontario Legislature's Social Policy Committee. You can view highlights of the second reading debate here: <https://www.youtube.com/watch?v=mYRIgQgDe2k>

I have been pushing for the Standing Committee on Social Policy to schedule a time to begin the work of reviewing Bill 21 since November 2022. **Today marks 286 days since the Act passed second reading at the Legislative Assembly of Ontario.** Unfortunately, the Bill has yet to be called to committee.

Bill 21, which was formerly Bill 153 and 95, respectively, had passed second reading and was sent to the Justice Committee in December 2019, but was wiped off the order paper when Premier Ford prorogued the house in 2021. It was reintroduced early 2022 but did not have time to progress before the election.

Since I first introduced this Bill in 2019, the number of people who've reached out to my offices with heartbreaking stories of couples entering long-term care who are torn apart has skyrocketed. Simply put, Ontario seniors deserve dignity in care and should have the right to live with their partner as they age. Of note, Nova Scotia passed similar legislation, titled the [Life Partners in Long-Term Care Act](#) in 2021.

Following many meetings with stakeholders, it's clear that "care campuses" which offer different levels of care (independent, assisted living and long-term care) are the progressive model for investing in quality care for Ontario's aging population. Care campuses are an essential element to keeping couples together as they often age at different rates. This level of choice has been brought to my attention as especially important to rural and northern municipal leaders across Ontario. The care campus model for seniors housing that builds different levels of care has unique financial savings that will be critical as we grapple with a rapidly aging province.

We need the Bill to be called to the Standing Committee on Social Policy as soon as possible. We know that couples who are separated across Ontario cannot wait any longer for this legislative change to be made.

This letter will serve to advise that at a meeting of City of Quinte West Council held on March 6, 2024 Council passed the following resolution:

Motion No 24-167 – Notice of Motion – Housing Funding

Moved by Councillor Stedall

Seconded by Councillor Armstrong

Whereas the City of Quinte West is in need of \$28M in funding to complete the West End Trunk Sewer Main replacement in 2024, which is critical in the ongoing development of new homes in Quinte West;

And Whereas the City of Quinte West requires \$58.6M in funding to upgrade the Trenton Wastewater Treatment Plant Upgrade building to accommodate new homes to be built;

And Whereas the City cannot afford to increase Water, Sewer or Tax rates to fund all of this infrastructure;

And Whereas increased Debt to build the projects will just increase costs to Water, Sewer and Tax rates, or increased costs to developers;

And Whereas the City of Quinte West is currently experiencing a housing crisis from all citizens but specifically with regards to over 250 requiring housing, from Military members of CFB Trenton;

And Whereas City Council approved a Housing Action Plan with a projected 831 new residential units to be completed based on anticipated Housing Accelerator Fund funding over 3 years;

And Whereas the Federal government denied the City of Quinte West the Housing Accelerator Fund;

And Whereas the City of Quinte West is not currently eligible for funding under the Provincial Building Faster Fund as its population is below the threshold;

And Whereas the City of Quinte West may make application to the provincial Housing-Enabling Water Systems Fund which has only \$200M available in funding of which the province would only fund up to 73% to a maximum of \$35M for one project;

And Whereas additional funding has not been allocated from the Federal Government to enhance the Housing-Enabling Water Systems Funding;

Now Therefore Be It Resolved That the City of Quinte West calls on the Federal Government to re-evaluate their lack of funding for municipalities with a population less than 50,000 in rural Ontario and to make available funding for infrastructure programs to help build infrastructure to help build much-needed new homes;

And Further That the Province of Ontario be asked to invest more than the currently allocated \$200M into their Housing Enabling Water Systems Fund;

And Further That this motion be circulated to Prime Minister Justin Trudeau, Federal Minister for Housing, Ryan Williams MP, Premier Doug Ford, the Provincial Ministers of MOI, MMAH, and Todd Smith MPP, and all municipalities, for their support. **Carried**

Greetings,

I am writing to you today on behalf of the Ministry of the Environment, Conservation and Parks about recent decisions to move Ontario's environmental assessment (EA) program to a project list approach as part of the government's ongoing work to modernize environmental assessment processes.

Comprehensive Environmental Assessment Projects regulation and other regulations:

Over the past several years, we have consulted extensively on the government's proposal to move to a project list approach. Beginning in April 2019, the ministry consulted on a [discussion paper](#), which outlined a modern vision for the EA program.

Then in July 2020, through the [COVID-19 Economic Recovery Act, 2020](#), the *Environmental Assessment Act* (EAA) was amended to provide the authority to make regulations to support EA modernization, including identifying projects that would be subject to EA requirements in a regulation. The move to a project list approach is a shift from the current framework, where projects are mainly subject to the EAA based on who is undertaking the project, rather than the projects potential impacts.

In fall 2020, the ministry consulted on a plain language [project list proposal](#), which identified the projects the ministry was proposing be subject to the EAA. In fall 2021 and spring 2023, the ministry then consulted on draft regulations, including a draft of the proposed [Comprehensive Environmental Assessment \(EA\) Projects Regulation](#) (Part II.3 Projects – Designations and Exemptions regulation) (2021) and a plain language update to that proposal (2023). The proposals also identified that the ministry would be updating relevant guidance and making certain related amendments to the Class EAs.

After considering the input received on the regulatory proposals and the discussion paper, a number of regulations have now been made and related actions taken to move Ontario to a project list approach. These changes came into effect on February 22, 2024 i.e., on the day that the revised provisions of the EAA providing the authority to make these regulations came into force.

The project types that are now subject to EA requirements in Ontario are those projects that are designated in the Comprehensive EA Projects regulation (i.e., significant waste projects, significant electricity generation facilities and large waterfront projects) and those project types to which a class environmental assessment (Class EA) applies. The

Comprehensive EA Projects regulation also designates projects that are exempt from the comprehensive EA requirements conditional on following a streamlined EA process (i.e. waste, electricity and transit and rail projects). There is no impact to projects that followed an individual EA and were approved. All projects which have started an individual EA application (i.e., a proposed Terms of Reference has been submitted to the Ministry) will continue in the comprehensive EA process.

We also wanted to note that these changes do not affect the continued authority under the Act to designate other projects or classes of projects as ones subject to a comprehensive EA or to enter into agreements with proponents to have the Act apply to projects that are not designated in the Comprehensive EA Projects regulation or otherwise.

Details of the decisions and changes made to move Ontario's EA program to a project list approach (the regulations, other instruments and related material) are on the Environmental Registry of Ontario at: <https://ero.ontario.ca/notice/019-4219>.

Complementary amendments to class environmental assessments:

To align Class EAs with the amendments to the EAA and the new and amending regulations made under the Act, including the Comprehensive EA Projects regulation, complementary amendments have been made to seven class EAs. Information on the amendments can be found on the Environmental Registry at: <https://ero.ontario.ca/notice/019-8081>.

Updates to guidance:

Similarly, we have updated the Guides to the EA requirements for waste and electricity projects and the guidance for transit and rail projects to align these with the Comprehensive EA Projects regulation and revised provisions of the EAA. These updated documents can be found on the Environmental Registry at: <https://ero.ontario.ca/notice/019-4219>.

Extension of expiry dates for certain approvals:

In November 2021, the ministry began consultation on a proposal to extend the statutory expiry date for *EAA* approvals by 10 years for certain projects.

A decision has now been made to extend the expiry date by 10 years for eight of those projects. The extensions will allow the projects to proceed instead of requiring a new environmental assessment to be completed. To ensure the protection of the environment, cultural heritage resources and source water, and to be responsive to comments received, including from Indigenous communities, the Minister made the extensions of the expiry date subject to conditions for seven of the eight projects. More information on the decision can be found on the Environmental Registry at: <https://ero.ontario.ca/notice/019-4428>.

The ministry carefully considered the nature and context of each of the projects. This included input from the proponents, the outcome of consultation undertaken in relation

to the proposal to extend, including consultation with Indigenous communities, and the purpose of the Act.

We are committed to keeping you updated and working with you to build a strong EA program for Ontario. We value your perspectives on the EA program and look forward to your further participation.






Health Promotion

Public Health Nurse-Delivered Group Cognitive-Behavioural Therapy (CBT) for Postpartum Depression

Description of Program:

Public Health Nurse (PHN)-delivered group Cognitive-Behavioural Therapy (CBT) is an evidence-based intervention for postpartum depression. Renfrew County and District Health Unit (RCDHU) will be implementing PHN-led CBT Workshops for clients within Renfrew County and District (RCD) who are pregnant or less than 18-months postpartum. These workshops provide an effective, brief option for birthing parents, reducing postpartum depression and anxiety, as well as improving social support, the mother-infant relationship, and positive affectivity/surgency in offspring.

Components of the workshop include both cognitive and behavioural techniques, which will provide psychoeducation and support to clients. As a result of the workshop, there is also an opportunity for participant referral to the Healthy Babies Healthy Children (HBHC) Program at RCDHU. Follow-up with participants is included to provide additional support and guidance. There is the option for both virtual and in-person workshop delivery, depending on the needs of the RCD community. Due to the versatility of the workshop, there is a future opportunity for community partnership to ensure reach to vulnerable populations within RCD that meet workshop eligibility.

Description of Team:

PHNs assigned to program areas within Health Promotion at RCDHU are being trained to facilitate the program. In addition, a team lead will provide ongoing support and assistance with developing, implementing, monitoring, and evaluating the workshop.

Preventing and Reducing Substance Use Related Harms

Our substance use and harm reduction team continues planning to support the development of a community-wide drug strategy. We will be hosting the first Opioid Overdose Response Plan team meeting of the year in early March. These are regularly scheduled meetings between community partners to monitor and respond to the

changing drug-related harms situation across RCD. In addition to the usual updates, we will be asking members to provide initial input on a community drug strategy. Furthermore, we will continue this discussion at the substance use collective action summit being planned later in March. A comprehensive strategy will address prevention (including as this relates to housing and mental health), harm reduction, treatment, and enforcement and require extensive intersectoral community participation.

The establishment of the MESA initiative involving the County of Renfrew paramedic services, community services, and development and property is an exciting advance with the potential to enhance our collaborative community efforts. In addition to upstream approaches, the initiative includes a mobile services component for the most vulnerable in our community that will provide wrap-around medical, harm reduction, and social services support. We look forward to continuing to support these initiatives through Public Health's preventive and harm reduction lens.

Health Protection

Healthy Environments

Rabies:

The rabies virus infects mammals' nervous system and can be spread to humans through the bites or scratches of infected animals. After the bite or scratch of a potentially infected animal, rabies can be prevented through timely treatment. Once rabies symptoms appear, the disease is almost universally fatal, regardless of the treatment offered. Therefore, preventive work is essential.

Our healthy environments team plays an integral role in preventing rabies through follow-up after all animal exposure incidents, which require reporting to Public Health. Depending on the incident, follow-up includes doing a risk assessment for rabies exposure, surveillance of involved domestic animals, animal rabies testing, and arranging treatment. A potential rabies exposure is defined as a bite from a mammal, non-bite (scratch or contact with saliva) from a mammal, or direct contact with a bat. Prompt cleaning of any wound is always essential. Depending on the risk-level of the incident, vaccination and administration of antibodies (i.e., immunoglobulin) may be required. These treatments are called post-exposure prophylaxis (PEP) and should be started as soon as possible after the exposure. PEP treatments typically take 14 days to complete.

Public Health Inspectors investigate and respond to all animal exposure incidents. In 2023, 238 exposure incidents were investigated, with 25 incidents requiring PEP. Some of the animals involved were bats, dogs, cats, groundhogs, and raccoons.

RCDHU staff plan to run the Yellow-Ribbon Campaign for rabies prevention later this Spring. The campaign asks that dog owners place a yellow ribbon or collar on their pets to remind people to ask before petting, to prevent avoidable animal biting incidents. The campaign also educates the general public on the significance of the yellow ribbon or yellow dog collar. The first year of the campaign in 2023 was a social media success with many pet stores and veterinary clinics taking part.

Upcoming Seasonal Activities:

With the approach of spring weather, special attention is being paid to monitoring the freshet (spring ice melt) in March.

Warmer weather also brings renewed outdoor interactions with ticks. Tick dragging will occur once again this year, with RCDHU staff targeting locations bordering risk areas and near waterways to get a better sense of the spread of ticks in RCD.

Immunization

COVID-19 and Influenza Vaccine:

As the winter season has progressed, demand for both COVID-19 and flu vaccines has decreased. Both vaccines remain accessible through participating pharmacies, some primary care providers, and RCDHU booked appointments for children under 12 and those at higher risk. As of February 3rd, RCDHU has administered 7840 doses of COVID-19 vaccine, and 3742 doses of influenza vaccine via mass community-based clinics, in-home vaccination services, and mobile vaccination services to retirement homes and congregate care settings. As of February 3rd, pharmacies in RCD have administered 11,884 doses of COVID-19 vaccines and as of February 7th, 14,179 doses of influenza vaccine.

Respiratory Syncytial Virus (RSV) Vaccine:

RCDHU continues to work with eligible partners to promote and administer of the RSV vaccine. As of February 12th, RCDHU has supported 3 mobile immunization clinics to eligible facilities and hosted 2 community clinics, resulting in a total of 160 doses of RSV vaccine being administered. RCDHU also supports the distribution of the RSV vaccine to eligible health care partners. As of February 12th, approximately 500 doses of vaccine have been distributed.

Immunization of School Pupils Act (ISPA):

ISPA work continues to occur throughout the winter months in RCD. As of February 17th, 2911 students were overdue for at least one ISPA vaccine (forecasted until June) or missing immunization information. Over the prior two weeks (Jan 28-Feb 17), approximately 500 students were brought up-to-date on their immunizations. RCDHU

anticipates seeing a further decrease in the number of overdue students in the coming weeks as the RCDHU immunization team will be hosting school-based clinics in all 11 high schools across RCD, and community-based clinics for students to attend. Both school and community-based clinics are planned to occur until the end of March 2024. Students can also be vaccinated through their health care provider, and report their immunizations back to RCDHU, preferably through the online [Immunization Connect Ontario tool \(ICON\)](#) or via fax, mail, or email.

Invasive Group A Streptococcal (iGAS) Infections

RCDHU, Canada as whole, and multiple other countries have noted significant increases in iGAS infections over the past year. Typical, non-invasive group A streptococcus infections are relatively common (e.g., strep throat) and are not reported to the Renfrew County and District Health Unit (RCDHU). In rare cases, the group A streptococcus bacterium becomes more serious and invasive, infecting the blood, tissues, or muscle. These iGAS infections are reported to RCDHU to enable monitoring and actions to protect others from infection. In 2023, 20 iGAS cases were reported, compared to an average of 6 cases reported each year from 2019-2022.

The increase in iGAS infections is likely related to multiple different factors and is not completely understood. Changes in respiratory virus infection patterns may be partly responsible, as these illnesses increase the risk of group A streptococcus infection. Another contributing factor may be reduced exposure to group A streptococcus over recent years due to measures used to control COVID-19, which also reduced the spread of many other infectious diseases. This may have resulted in a temporary decline in immunity against group A streptococcus, and therefore more susceptibility last year. Finally, an increasing trend of invasive group A streptococcus across Ontario was apparent in the years before the pandemic. While measures used to control COVID-19 were associated with a reduction in invasive group A streptococcus, we may now be seeing a continuation of this previous trend.

People most at risk include those with chronic medical conditions, people with weakened immune systems, older adults, and young children. Severe, invasive infections from group A streptococcus remain uncommon, however, it is important to be alert and take precautions. Important precautions to reduce the risk of a group A streptococcus infection include:

- Frequent hand washing, especially before preparing or eating meals and after coughing or sneezing,
- Keeping wounds clean and monitoring for signs of infection, such as marked pain, redness, swelling, and drainage,
- Being vaccinated against viral illnesses that increase the risk of a group A streptococcus infection, including chickenpox, COVID-19 and the flu.

Anyone who is concerned about a group A streptococcal infection should act quickly and seek advice from their healthcare provider, Renfrew County Virtual Triage and Assessment Centre (RC VTAC), or Health811.

- Prolonged fever and sore throat or fever and sore throat without associated cold symptoms (like cough and runny nose) are typical group A streptococcus symptoms.
- Rapidly worsening symptoms or severe symptoms such as trouble breathing, difficulty swallowing, or confusion should prompt emergency medical attention.

Respiratory Infections

Outbreaks:

Respiratory-related outbreak activity so far in 2024 has remained relatively consistent, with an average of 2 new respiratory outbreaks declared each week. There are currently 3 active respiratory outbreaks in RCD (as of February 13th).

Respiratory Disease Outcomes:

Some people are at higher risk of more severe disease or outcomes from respiratory illness infection than others. In the past 6 weeks, hospitalizations for COVID-19 have decreased to approximately 4 new admissions per week, down from 7-8 new admissions in November-December 2023. Hospitalizations for influenza continue to be reported by local hospitals.

RCDHU continues to review fatalities related to COVID-19 as information becomes available. Since November 2023, RCDHU has confirmed 14 COVID-19-related deaths.

Test Percent Positivity and Cases:

As of February 13th, a total of 31 influenza cases have been reported to RCDHU. Provincially, percent positivity for influenza A appears to have peaked in late December 2023 and currently sits around 10%. Percent positivity for influenza B remains low but has increased in recent weeks.

With respect to COVID-19, over the past few weeks, testing percent positivity for both Ontario and Eastern Region health units has been trending downward (9-10%). Our local positivity has also been decreasing, currently around 15% and is projected to decrease below 10% in the next week or so.

Wastewater:

Preliminary data for Ontario overall and for Eastern Region health units shows that COVID-19 wastewater signals are decreasing after peaking mid-end December 2023. Local signals from both Pembroke and Petawawa sites show a similar trend.

In addition to monitoring COVID-19 signals in wastewater, RCDHU is monitoring influenza signals this 2023-2024 season. Increases in influenza A signals were observed at both Pembroke and Petawawa sampling mid-December 2023, a few weeks prior to the first influenza A outbreak declared in January 2024. Supported by other influenza-related indicators, recent wastewater signals suggest that influenza continues to circulate in our communities.

Sexual Health - GetaKit

GetaKit is a University of Ottawa initiative aiming to assess the effectiveness and outcomes of a mailout HIV self-testing program. Launched in July 2020, the online platform provides Ontario residents with the accessibility of ordering an HIV test kit online to be completed in the privacy of their homes.

Since its launch, the GetaKit program has evolved to offer additional services beyond HIV testing. The program facilitates lab requisitions ordered by local Medical Officers of Health for chlamydia and gonorrhea testing, which can be conducted in local laboratories.

To ensure appropriate testing recommendations, individuals are required to complete a questionnaire prior to any testing. Based on this information, the program determines the types of testing suitable for the individual's needs.

Given the potential to enhance accessibility of testing and reduce spread of sexually transmitted infections (STI), last September RCDHU was the third public health unit across Ontario to join the Getakit program, making it available to RCD residents. In support of the program, our STI treatment medical directives were updated and our staff were provided with training. RCDHU will provide any RCD resident with a positive test result with assistance on education and obtaining treatment.

As of February 10th, GetaKit has successfully served 29 RCD residents. Since promotion of the program only began recently, we anticipate increased uptake in the months to come.

BY-LAW NUMBER 2024-06

2. **THAT** the Mayor and the appropriate officials of the United Townships of Head, Clara & Maria are hereby authorized and directed to do all things necessary to give effect to the action of the Council of the United Townships of Head, Clara & Maria referred to in the proceeding section.
3. **THAT** the Mayor, or in the absence of the Mayor, the alternate head of council and the Municipal Clerk, or in the absence of the Municipal Clerk, the Deputy Clerk, or in the absence of the Municipal Clerk and the Deputy Clerk, the Acting Clerk, are authorized and directed to execute all documents necessary in that behalf and to affix thereto the corporate seal of the United Townships of Head, Clara & Maria.
